### Global Challenges

- "Global Challenges" is one of the four thematic programmes under NDICI-Global Europe
- Focuses on global action to tackle global challenges with a wide scope of intervention areas (Annex III of NDICI-Global Europe)
- Supports EU's ambition as a "stronger global actor" and a "champion of multilateralism"
- In line with NDICI-Global Europe philosophy: geographisation, subsidiarity, complementarity
- Complementary to regional, country and thematic MIPs
- EUR 3.3bn



### Global Challenges

#### Focus on **global action**, notably in support of:

- i. multilateralism and international governance
- ii. global/multilateral processes, funds and programmes
- iii. global/trans-regional advocacy, research, innovation, public goods and knowledge
- iv. global/trans-regional networks, information and Early Warning Systems
- v. global standardisations
- vi. innovative approaches and pilots

## People

To push forward the global agenda for inclusive and equal societies with human development for all, with a specific focus on women and girls, children, young people, and other populations living in vulnerable situations, including migrants and forcibly displaced.



### People – priorities



**Health:** Strengthen EU leadership in global health, contribute to ensuring healthy lives and promote well-being for all with a specific focus on universal health coverage, access to basic health services, health security and communicable diseases, as well as sexual and reproductive health and rights.

**Education**: Strengthen EU political leadership in shaping the global education agenda and promote the alignment of global actors and partner countries around a common set of education priorities.

Migration and forced displacement: Support the achievement of EU political commitments, promote the positive impact of migration on development, and ensure EU influence, voice and visibility in multilateral frameworks.

Gender, children and youth: Advance the gender equality agenda in line with the EU Gender Action Plan for EU external action, including on sexual and gender based violence. Strengthen the participation of children and young people in decision-making and create bridges between children and youth in Europe and in partner countries.





## Planet

To support global action to tackle the global climate and environmental crises and support the green transition to climate-neutral sustainable development pathways.



#### Planet – priorities



Climate action: Promote global transformative action to tackle climate change, progress towards climate neutrality and enhance climate resilience and DRR

**Environment:** Strengthen international environmental governance and action to address global environmental challenges – biodiversity, oceans, forests, water, land, pollution

Green transition: Drive the global transition to clean energy, sustainable cities and agri-food systems, circular economy and sustainable mobility



## Prosperity

To support sustainable and inclusive economic recovery and growth, climate-neutral and sustainable economic development and progress in human development



### Prosperity – priorities



Investment climate, private sector, decent work, employment and trade: Promote sustainable and inclusive growth and creation of decent jobs and supporting labour rights for men and women, fight against inequalities, enhancing sustainable and inclusive investment climate, and the development of a socially and ecologically responsible private sector.

**Circular economy:** Global transformative action to promote sustainable consumption and production, a circular economy and foster sustainable development while decoupling economic development from the unsustainable use of natural resources.

Global action to eradicate child labour: Contribute to the fight against inequalities and forced labour.

**Digital transformation:** Support global efforts to promote digital transformation with appropriate digital and data technologies in view of the transition to inclusive, climate-neutral, resilient, and sustainable economies.

Sustainable agri-food systems: Support global efforts to promote the transition to inclusive, climate-neutral, resilient, and sustainable agri-food systems, with a particular focus on sustainable agriculture, nutrition and food security.

## Partnerships

To promote a rules-based, inclusive multilateralism and global governance, build and expand multilateral networks, partnerships and actions, and build capacity for inclusive societies and progress assessment



### Partnerships – priorities



Dialogue and cooperation with multilaterals: Promote a stronger Europe in the world by strengthening dialogue and strategic cooperation with global and multilateral organisations on global public goods and challenges, support the implementation of international commitments, and contribute to the effective reform of multilateral institutions.

Global economic governance: Promote good economic governance, including fair and inclusive domestic revenue mobilisation, especially in the context of international tax cooperation by implementing measures against tax avoidance and evasion, transparent public finance management and effective and inclusive public spending.

**Inclusive societies:** Support global associations of local authorities to improve their transparency, accountability, advocacy capacities and empowerment.
