Country Level Implementation Plan Kosovo (2021-2025)



The European Union and its Member States are vigorously promoting gender equality and women's empowerment in their relations with partner countries. The new EU Action Plan on Gender Equality and Women Empowerment in External Action (2021–2025) is now operational in Kosovo

#### **GAP III**

The Gender Action Plan III (GAP III) commits to promoting gender equality and women's empowerment by monitoring progress in furthering gender equality issues and prevention of violence against women and girls in all sectors. The EU, its member states, and representatives in Kosovo, together with other stakeholders and CSOs, are actively engaged in promoting GAP III in Kosovo.

#### **Vision**

Our vision is to further gender equality in decision-making, justice, peace, security and equal representation in the security sector as per the Convention on the Elimination of all forms of Discrimination against Women, the Istanbul Convention, UN Security Council Resolutions 1325 on Women, Peace and Security, and existing laws and policies in Kosovo.
