Why do forests matter to you?

Forests are a public good. Apart from cleaning the air we breathe and our water, holding the soil, sequestering carbon from the atmosphere and being home to a multitude of biodiversity, they provide the world's most environmentally friendly, sustainable renewable resource which is wood that humans can use for energy, and products used in everyday life for shelter, food, logistics etc

What are the main challenges to forests in your area today?

They include forest degradation and deforestation due to expanding agricultural activities, construction development and energy.

What is your idea of sustainable forest management?

This is a planned and deliberate effort undertaken to grow trees, manage them, harvest and replant. It entails turning the wood value chain into a cycle. It also supports the protection and conservation of natural forests and juxtaposing this with the establishment of forest plantations to provide timber, poles and fuel wood to support the value chain.

How can sustainable forestry contribute to create jobs and income?

The promotion of commercial wood value chains is premised on the long-term planning of raising fast growing straight trees and harvesting them in a manner that optimises efficiency, uses all the wood material available to make wood products. This requires a dedicated and skilled labour force that has been trained and has expertise in silviculture, forest management, harvesting and wood processing .

Pinus auracaria.






Which forest-related achievement do you admire most?

How can the European Union better support your country's objective in relation to the forestry sector?


