

## Lao PDR: Context

Key-data on TVET, education, labour market

- 42.1% of youth not in employment, education or training (NEETs) 2019
- Low participation in formal VET (6,500 enrolment vs planned 21,000); 2022-2023 (MoES)
- Massive labor migration to ASEAN neighboring countries
- Labour-market demand in higher specialised professions not met
- Budget constraints often temporarily solved by ODA
- Lack of knowledge among youth about career opportunities after TVET

## Lao PDR: TVET reforms

Main elements in TVET reforms in the past 5 years

- Employment Law / Skills Development Law, MoLSW
- Revised TVET Law / Lao Qualification Framework / 5-years TVET Development Plan, MoES
- 14 Occupational Standards (Agriculture, ICT, Automotive), MoES
- Development of 28 CBT; 18 DCT (273 cooperated enterprises), MoES
- TVET Development Fund (to be approved soon), MoES
- Reform objective: to coordinate TVET measure among MoES and business sector (represented by LNCCI) and MoLSW
