### **REGIONAL CONTEXT**

Intraregional migratory flows level in Western Africa remains among the highest in the world and the majority of African migrants stay in the continent or sub-region.

Irregular migration from Africa has also affected EU Member States, and there was a substantive rise in flows in the last years along the Atlantic/ Western Mediterranean route. The negative effects of the COVID-19 pandemic in origin and transit countries and the lasting deteriorating security situation in the Sahel make the prospects worrisome.

### TEAM EUROPE PROPOSAL

Strengthen coordination, coherence and complementarities of actions funded by the EU and by EU MS on migration and forced displacement and focus on migration management and migration governance actions, putting migrants, refugees, and their host communities first.

#### Actions carried out at national, multi-country and regional levels under 5 pillars of intervention:

- 1. Legal migration and mobility enabling environment for legal migration and mobility pathways development and promotion of legal migration and mobility pathways.
- Protection and Asylum ensuring protection, resilience, self-reliance, life-saving assistance including life-saving assistance, to migrants, asylum seekers and refugees, in line with international humanitarian law.
- 3. Prevention of irregular migration, countering migrant smuggling and trafficking in human beings supporting partner countries in
- developing and implementing effective migration governance and management systems.
- **4.** Return, readmission and reintegration Supporting safe assisted voluntary return, readmissionand sustainable reintegration in countries of origin.
- Migration and development promoting the development benefits of migration as well as addressing socio-economic root causes and targeting concrete challenges of irregular migration.
