WATER

Health risks:

- Insufficient sanitation, sewage discharge and wastewater treatment
- Consequence on the availability and productivity of the labour force

NATURAL RESOURCES

Inadequate management of natural resources:

- Unsustainable agricultural practices
- · Unregulated herding of livestock
- Hindrance for Lesotho's socio-economic development

- Climate change has a direct effect on resources
- Need for effective regional water management with riparian states to avoid regional conflicts over access to water
