

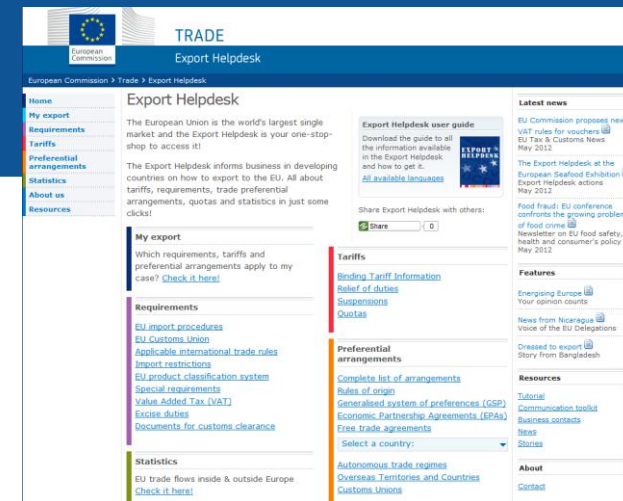

## With whom can I do business?

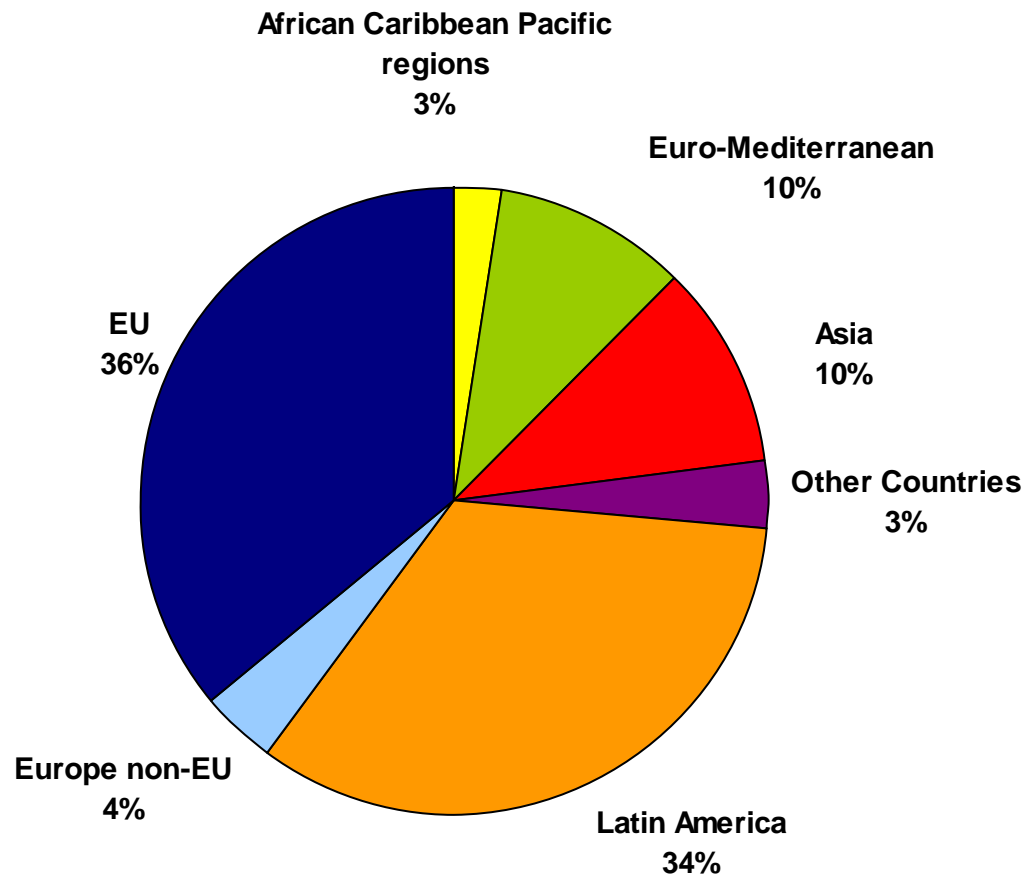
It provides you with a list of **EU trade contacts**

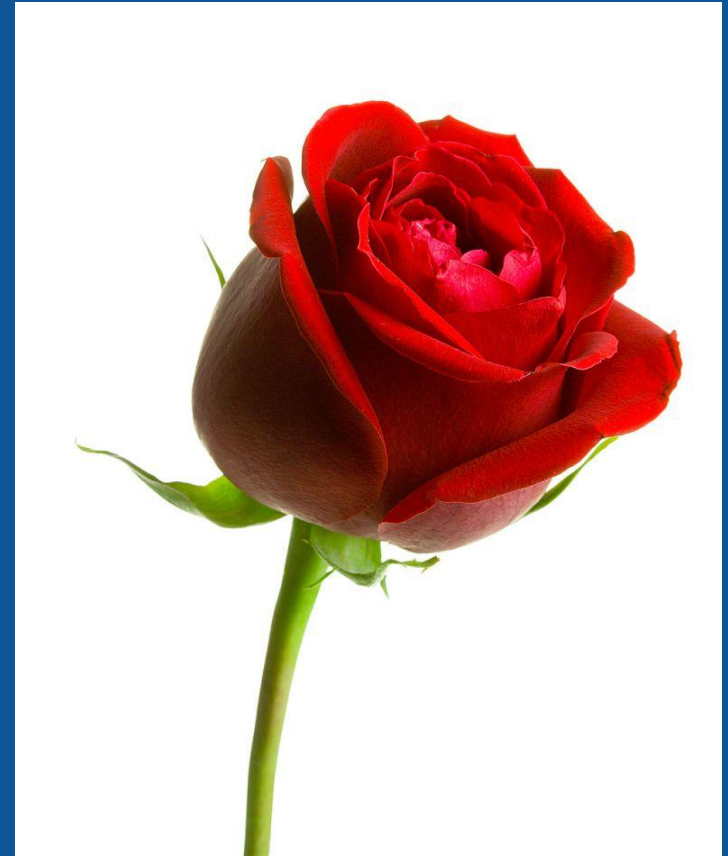

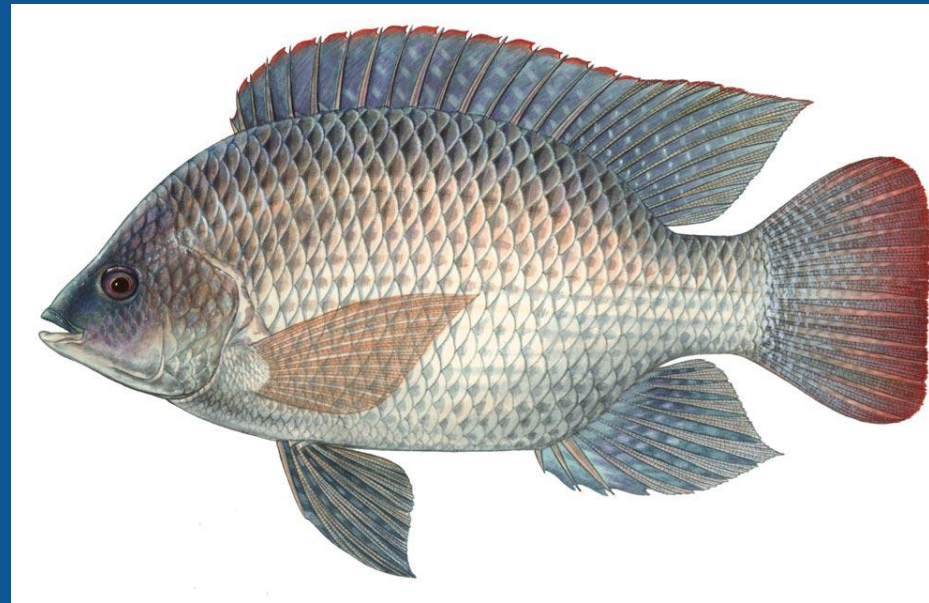
