### **WHAT IS SOCIEUX?**

- Technical assistance facility
- Established by EuropeAid
- Supporting partner countries to better design and manage Social Protection systems
- Via short-term (1-2 weeks) peer-to-peer support
- By experts from public administrations primarily from the EU MSs + Partner Counties + IOs



### SEVEN FEATURES OF SOCIEUX

("there are already many programmes, so.....?")

- 1. Quick: implementation seven weeks after approval of a request
- 2. Flexible
- 3. Demand driven/ownership
- 4. Short-term: one to two weeks
- 5. Mainly EU MSs public administration experts
- 6. South/South or Triangular Cooperation
- 7. Peer to peer

### **HOW DOES SOCIEUX WORK?**

From request to approval and M&E is organised in four phases:

- 1. Request made by Partner Country: assessment 3 weeks
- 2. Approval Process: 2 weeks
- 3. Preparation (7 weeks) and implementation Process (1 or 2 weeks)
- 4. Evaluation



## STEP 1. REQUEST MADE BY PCs

- Simple request form; yes it is demand driven, but......
- SOCIEUX assessment criteria check
- Action Approval Form/ToREx
- Experts search starts: how?

# THE EXPERTS SELECTION PROCESS

- Experts primarily from EU MS-administrations, but.....
- Role for South/South or Triangle Cooperation: mutual learning and best practise on different levels
- Experts are selected in a non-discriminatory and transparent procedure, using EU standards



### **EXPERTS PROFILE**

- Experience in the area of assistance
- Experience providing technical assistance in international contexts, especially in developing countries
- Experience in the beneficiary country
- Requested language skills
- The best expert? Sometimes: "Another road taken....."



### STEP 2. EUROPEAID APPROVAL PROCESS

Big role for EuropeAid in assessing the Action Approval Form (2 weeks)



# STEP 3. PREPARATION/IMPLEMENTATION PROCESS

#### Role for:

- EUDs: contacts, country background and profile
- Requesting institution: background info, counter part.
- SOCIEUX team: experts briefing, finance, contract, travel, insurance, visa.

Fully standby and support of the SOCIEUX team.



## STEP 4. M&E PROCESS

Several levels: Mission Report, Questionnaires, debriefing and overall Evaluation: input to improve.

#### Challenging interaction between:

- rapidity
- sustainability
- relevance and
- ownership (demand driven)



### FIVE AREAS OF ASSISTANCE

(based on the definition of Social Protection)

- 1. Social insurance
- 2. Social assistance
- 3. Access to basic social services
- 4. Financing of social protection systems
- 5. M&E systems, statistics and registration systems



# MANY TYPES OF INTERVENTIONS

- Fact-finding missions
- Screening and reviews of documents
- Support in drafting legislation & strategies
- Roundtable discussions
- Direct and peer to peer approaches
- Train-the-trainer seminars
- Technical trainings

# SOCIEUX'S ADDED VALUE FOR MSs

- The heart of the EU Social Model and of the ILO Floor
- SOCIEUX is in line with (adopted) national supportive initiatives
- The mutual interest through peer-to-peer
- Experts with new ideas and input from different cultures and perspectives, looking "outsideinside" inspire the EU administrations.



# SOCIEUX'S ADDED VALUE FOR EXPERTS

- Networking, learning and gaining international experience
- Improving skills in training delivery and feedback under different and difficult circumstances.
- First-hand experience of social protection systems
- Contribute to enhancing cooperation EU/PCs.



### **TIMING**

- Programme runs till April 2016
- Length of individual activities: 1-2 weeks.

governmental groups.


SOCIEUX is a demand-driven instrument. Partner countries submit requests for assistance in designing and delivering social protection systems.
