Addressing climate change in ACP countries: Strengthening regional exchange and synergies 5, 6 & 7th May 2014, Brussels

The Global Climate Change Alliance (GCCA) Intra-ACP Programme held the first Regional Technical Meeting (RTM 1) in Belize in 2013. The RTM 1 focused on four themes of common interest to the regional components namely: Integrated Disaster Risk Reduction and adaptation, impact and vulnerability; mainstreaming climate change into national development planning; and low carbon development. A main outcome was the establishment of four Thematic Networking Groups (TNGs). The Second Regional Technical Meeting (RTM 2) will build on the momentum generated by the RTM 1.

The Second Regional Technical Meeting

The objectives of the RTM 2 are to bring together the GCCA Intra-ACP Regional Components to:

- Continue improving communication and information sharing, including by strengthening the TNGs.
- Continue improving coordination, identification of synergies (among the regional components, with the ACP Secretariat and with other relevant ACP programmes) and promotion of shared actions.
- Learn about additional topics of common interest: climate finance, energy, private sector and Disaster Risk Reduction (DRR).

Participants will be high-profile representatives of the regional components' organizations, ACP Embassies and Missions in Brussels, Climate Change related programmes being implemented by the ACP Secretariat, the European Union, and European Union Delegations in the five regions, ACP partner organizations in Brussels, representatives from civil society and the private sector.

The meeting will be held in English and French, with simultaneous interpretation.
