# The Global Climate Change Alliance (GCCA)

- **2007 Policy Initiative** of the EU
- Objective: Help developing countries most vulnerable to climate change to **increase their capacities** to:
  - adapt to the effects of climate change
  - participate to global mitigation efforts
- Focus on **LDCs** and **SIDS**
- **290 million euros** (2008-2013) including funds from Republic of Cyprus, Ireland, Czech Republic, Republic of Estonia and Kingdom of Sweden





## The GCCA + Flagship Initiative

- 2014- 2020 Global Public Goods and Challenges
- On the basis of countries' demand, more attention may be to:
  - Adaptation + DRR
  - Ecosystem based adaptation
  - Urbanisation, urban mobility, social affairs and employment
  - Migration
  - Gender
- Broader range of actors: local authorities, NSA and private sector

### Six New GCCA Interventions are Approved, with Nine More in Final Stages of Approval

Last year, the European Commission committed €36.6 million for financing [six new GCCA interventions](#) in Burkina Faso, the Central African Republic, Lesotho, Papua New Guinea, Timor-Leste, as well as the Eastern Caribbean region. Now, under the 2013 action programme of the Thematic Programme for the Environment and the Sustainable Management of Natural Resources, including Energy, an additional nine programmes are in the final stages of approval.

### GCCA Sector Budget Support for Environment and Natural Resources in Rwanda comes to an end


