# Field of activity

The posts are assigned to the sector strategy and programme on "Sustainable Climate-friendly Management of the Environment and Natural Resources" in the Lao People's Democratic Republic. The implementing organisation is the Department for Forest Inspection in the Ministry of Agriculture and Forestry. The unit to which advisory services are to be provided are the Provincial Offices for Forest Inspection in Sayaboury and Khammouane Province. The aim of the GIZ programme is to create an institutional and technical framework that will allow negotiations on Forest Law Enforcement, Governance and Trade (FLEGT) between Laos and the European Union (EU) to be brought to a successful conclusion. After a Voluntary Partnership Agreement (VPA) has been reached, the timber and timber products destined for export to the EU will be awarded a FLEGT licence as proof that the wood comes from legal sources.

## **Your Responsibilities**

- You will provide advisory services on developing and testing timber legality assurance systems (TLASs), which allow legally produced timber and timber products to be traced along the entire supply chain
- You will supervise participatory processes that ensure all the key stakeholders are involved in developing practical tests (local government, authorities, private sector and civil society)
- You will provide support on designing and implementing training plans for the participating authorities at provincial level, for the state forestry companies and for wood processing firms in the private sector

## **Your Profile**

- Master/Bachelor degree in forest science/management or wood technology
- A knowledge of forestry, climate and environmental extension methods
- Experience in the forest management sector and/or timber management and the timber industry
- A good command of English and a willingness to learn a third language (Lao)
- Participatory advisory skills; excellent team and communication skills
- Knowledge and experience of organising training sessions and workshops

- Your role will include knowledge management and deriving lessons learned and best practices from relevant project results and experience in the pilot province
- You will support the partner organisation on project management and on developing monitoring and evaluation mechanisms
- A sensitive approach to working on topics of conflict
- Good IT and GIS/GPS skills and experience in public relations
- Experience with forest and timber certification systems
- Driving licence
