# A unique multi-stakeholder space for dialogue

Conceived as a trust-building mechanism, the EU Policy Forum on Development (PFD) brings together Civil Society Organisations (CSOs) and Local Authorities (LAs) from the European Union and partner countries with European institutions and bodies. It offers its members a high-level space to discuss, consult and exchange information and experiences, with the ultimate goal of promoting policy dialogue and enhancing mutual understanding.

The PFD reflects the dialogue aspirations of the Lisbon Treaty. The Forum also builds on international commitments to achieve development effectiveness, at both European and global levels.

In addition to the EU, all four key EU cooperation regions are represented: Africa; Asia and the Pacific; the European Neighbourhood Region; and Latin America and the Caribbean.



## The PFD pursues 3 key objectives:



• **Dialogue** on cross-cutting issues directly related to the role of CSOs and LAs as relevant development actors in their own right.



 Policy debate, consultation and exchange of information and experiences on key EU development policies and initiatives.



• Regular follow-up of the Structured Dialogue's recommendations providing a room for regular update and peer review by all actors.

## The history behind the PFD

## From the Structured Dialogue to the Policy Forum on Development: a progressive path

The PFD is the result of the Structured Dialogue, regarded by many development professionals as one of the most comprehensive, transparent and well-organised consultations ever launched in the field of development.

Organised in parallel with the global development effectiveness agenda debates in 2010 and 2011, the 14-month process brought together more than 700 CSOs and LAs - including grassroots, regional, national and global organisations - with European Union institutions and Member States to reflect upon and define ways to improve the effectiveness of all actors involved in EU development cooperation.

Launched in March 2010 and concluded in May 2011 by Commissioner Andris Piebalgs, the process ended with a final joint declaration, acknowledging CSOs and LAs as essential components of any working democracy and providing strong recommendations to all actors involved, including the set-up of a permanent space for dialogue, thereafter known as the Policy Forum on Development. The PFD held its inaugural meeting in November 2013 after an intensive interim phase, during which the forum was collectively shaped.

Key landmarks in the follow-up of the process are the Communications on engagement with CSOs (2012) and LAs (2013) in development, at the forefront of innovativeness, and the EC Staff Working Paper on Development Education and Awareness Raising (DEAR).

# Key figures and facts about the PFD

- > 61 key CSO and LA actors, which include 42 regional networks, 6 global umbrella organisations and alliances and 13 European platforms, are members of the PFD and sit together with representatives from EU institutions, bodies and Member States.
- the networks, alliances, platforms and their constituencies, across Africa, Asia and the Pacific, Latin America, the European Neighbourhood region and the EU.
- The global, regional and European voices of citizens, cities and local governments find their way into the PFD. Overall, one can estimate that the PFD potentially reaches out to:
- More than 260 co-operative federations, representing around a billion individuals in 92 different countries.
- 2.5 million Fair Trade producers and workers from 70 countries.
- Hundreds of millions of workers in 161 countries and territories.
- More than 1,100 cities and national associations, representing over half the world's population, present in more than 120 countries.
- More than 150 business and employer federations present in 143 countries.
- Key global and regional umbrella NGO actors and their constituencies across the world.


## How the PFD works

  - At least one global PFD meeting is organised every year, as well as one regional meeting.

EuropeAid is responsible for the overall organisation of the Forum and chairs the PFD. Unit B2 ensures the secretariat of the Forum. The PFD is co-chaired by one representative of the CSOs and by one representative of the LAs.


