# **JMP Organization and Strategic Directions**

- Proceed with the task-force on Harmonization (JMP, MACRO, WB, LSHTM, UN-HABITAT, EHP, PAHO)
- Establish task-force on National sector assessments (WEDC, PAHO, SEARO, WHO and UNICEF offices)
- Map the needs for national level capacity building on sector monitoring
- Implement water quality pilot, country reports
- Review + circulate JMP policies and procedures
- Prepare draft input to WWDR
- Organize 4th JMP-TAG meeting May 2005

# **JMP Methodology**

- Agree on harmonized question set
- Development of generic pictorial guide
- Agree with UN-HABITAT on coverage estimates in urban areas
- Data collection, entry and analysis
- Anchoring baseline, linear vs. curve linear, population vs. household based indicators
- Prepare wealth quintile analysis with DHS and MICS

# Capacity Building at the National Level

## Sector assessments

- Prepare guide on sector assessments
- Develop a position paper on the role of JMP in national sector assessments
- Proceed with country assessments

## Coverage data

- Disseminate latest JMP data set to countries
- Regional meetings to improve the use of JMP data at regional and national level
- Guidelines for Assessing Hygiene Improvement as complementary survey questions to the core question set
- Publish, promote and disseminate the harmonized question set through UNDG, UN-Water and regional meetings, for inclusion in national censuses and other household surveys.
- Finalize the pictorial guide, pre-test and disseminate it together with the harmonized core questions set to country offices

# Advocacy and Communication

- Publish JMP annual review 2004
- Publish 2005 JMP report for Water Decade
- Develop a JMP advocacy and communication strategy
- Put together a package for country level dissemination
- Promote the acceptance of JMP data at national level through the UN-resident coordination system to ensure the use of JMP data for national MDG monitoring.
- Hold regional meetings for national statistics offices and leading national sector professionals to explain the JMP methodology and promote the JMP estimates for use as official reference data for MDG monitoring and PRSPs
- Conduct work on research and use of the JMP data set
- JMP website: keep it updated with latest JMP estimates and latest available survey data

## Summary of Future issues



### *Accurately assessing "safety" (drinking water quality)*

- Pilot work in hand

### *Harmonizing different surveys*

- Tools developed
- Discussion with implementing agencies

### *Measuring gender disparities*

- Household surveys do not allow disaggregation by user (gender)
- Work to disaggregate who collects water and time invested is in hand
