- **Launched in Johannesburg, WSSD 2002**
- **Strategic partnership between Africa and EU**
- **Joint goals:**
 - Plan of Implementation
 - To achieve the MDGs

- **Reinforce political will & commitment to action**
- **Effective governance and institutional capacities**
- **Improve coordination and cooperation**
- **Increase efficiency of existing EU aid flows**

EUWI Water Supply & Sanitation

Working Group WSS of the EUWI

Composition:

- AMCOW-TAC: 5 members for sub-regions
Lesotho (co-chair), Congo Brazzaville, Kenya, Morocco, Ghana
- 3 EU members: Denmark, Netherlands (co-chair), Germany & EC (M. Walshe)

Action Plan: regional & country actions



Action Plan of the WSS of the EUWI

Regionally:

- **Prioritisation of WS&S**
- **Innovative funding**
- **Best practice sharing**
- **Multi-strategy for less and more developed countries**



Action Plan of the WSS of the EUWI

Country-wise:

- **Policy dialogue, PRSP incorporation**
- **Road mapping**
- **Financing plan**
- **Capacity building plan**
- **Harmonization and coordination**

Selected countries & supporting EC member:

- **Ghana (Denmark) : under way**
- **Cape Verde (EC)**
- **Rwanda (?)**
- **Ethiopia (UK): starting up**
- **Mozambique (Netherlands): starting up**
- **Zambia (Germany): under way**
- **Egypt (?)**
- **Mauritania (?)**
- **Congo Brazzaville (France?)**
- **Central African Republic (?)**

Proposal by AMCOW TAC and EU Co-Chairs

- **Organize national policy dialogues with multi-stakeholder forum & roundtables**
- **Multi-stakeholder forum: to identify the bottlenecks**
- **Make road maps to achieve the MDGs**
- **Mobilize strategic partners (WSP, Unicef, EC members) support**
- **Develop plans within the road map: for capacity building, financing, harmonisation, etc**

The African partner country's government will be expected to

- **Ensure the selection of the facilitating organisation, in consultation with the EU MS involved, and supervise its work;**
- **Act as, or mandate, a convenor for the multi-stakeholder forum;**
- **Ensure an anchorage of the process within their national institutional structure.**

The EU MS involved in each country will be expected to

- **Lobby with other donors concerned for harmonization of support for the roadmap to achieve the MDGs;**
- **Co-ordinate with the government and with the Finance Working Group of the EUWI on a broad financing strategy to support the roadmap to achieve the MDGs;**
- **Host and organise a roundtable (consultative group meeting) of bilateral donors, NGO's, CBO's, private sector and international financing institutions, to coordinate cost-effective funding of the roadmap.**

All parties will be expected to:

- Annual review and monitor progress

The African country's government will be expected to:

- Make an annual water, sanitation and hygiene (WASH) report on progress
- To continue this annual reporting until 2015

The EUWI will be expected to:

- Facilitate the exchange of experiences between the ten pilot countries
- Assist in political coordination and guidance
