A joint sector approach with MS (SE, IE and DE) is envisaged to build a healthier, adequately fed educated and resilient population, with youth and women acting as agents of change making a transformative and multifaceted impact on Zambia's social, economic, and political development.

One point of entry will be on early childhood education, but the programme will also focus on health and multisector approaches to nutrition.

Joint funding is envisaged to finance this project, as well as potentially budget support (discussions ongoing).
