## **KEY DELIVERABLES**

#### Transpor

1. Construction of the "Metro de Bogota" for a moreinclusive and environmentally fair transport system that contributes to Bogotá becoming carbon neutral city by 2050.

#### Water and biodiversity

- 2. Restoration of the swamp "Cienaga of Mallorquin" (design and feasibility studies).
- 3. Establishment of a territorial water governance system in intermediate and small high mountain towns in the Atriz Valley Water Region (500.000 ihabitants), which share water sources and need to develop collaborative tools for their water security.
- Improvement of water and sanitation in Medellin, including by guaranteeing access to drinking water and basic sanitation to inhabitants.

#### **Food production value chains**

 Development of resilient food production in horticulture-livestock systems for 200 families through technological innovation in climatically vulnerable regions of Argentina and Colombia.

### Renewable energy

 Commercialization of green low-carbon technologies of European small and medium-sized enterprises and companies in Argentina, Brazil, Canada, Chile, Colombia and Mexico (DG GROW, FPI).
