#### Institutional capacity building.

Strengthening climate change governance (TAIEX, Twinning).

Access to local climate relevant data and its analysis (DE ADAPTE project – GeoPortal)

Improve management of watersheds and wastewater management (GEF-funded CREW+ programme – GIZ, IDB).

Make operational the National Climate Change Fund (TA, Euroclima+)

#### **Improving resilience (TA, TAIEX):**

- Agriculture value chains adaptation to climate change.

Energy efficiency investments in the private sector (pilot scheme - LAIF, EFSD+ guarantees scheme, National commercial bank).

Strengthening access of small farmers to markets (value chains), sustainable production, marketing and consumption (WB-IFAD-EU blending operation).

#### TRANSFORMATIONAL POTENTIAL

Development of sustainable economic model that combines economic development with sustainable resource management, environmental and biodiversity protection,

- · Promotion of blue, green and circular economies
- Development of sustainable and resilient small-scale agriculture
- Supporting the achievement of NDCs.
- Sustainable forest management (conservation and exploitation) and recovery of lost forest masses.

# **KEY DELIVERABLES**

#### Biodiversity

- Restoration of 30.300 hectare of forest through community management plans by 2025; 600 000 hectares registered under sustainable forest management and forest incentive programmes and 1 000 000 hectares with forest fire prevention and control measures.
- 2. Establishment of three centres for agro-ecological innovation for the transfer of climate change adaptation and mitigation technologies. Improvment of 19.500 hectares of agricultural land with conservation practices by 2025, leading to reduction of severe and moderate malnutrition in 10,000 people.

#### Water and sanitation

3. Construction of a sanitary landfill, four sewage networks and four wastewater treatment plants in order to increase the number of people benefiting from waste management systems by 100% in up to 5 of the most populated municipalities of Peten.
