# **KEY DELIVERABLES**

#### FCCB Policy, data and institutional frameworks

 Improvement of the Institutional framework for Forestry, Climate Change and Biodiversity (FCCB) to achieve effective implementation of evidence-based FCCB policies, governance and institutional frameworks. This will include, among others, the improvement of data collection methods, governance frameworks and a transparent and functioning carbon trading mechanism.

#### **FCCB Awareness and Education**

2. Knowledge and awareness on FCCB issues among PNG's population increased. This will include the mainstreaming of FCCB issues in primary, secondary education, specialized colleges and also the increase of funding opportunities for the academia to strenghten their research in this sector. Awareness about FCCB issues will be strenghtened with public, private sectors, civil societies groups such as women, youth, traditional landowners to be empowered in the FCCB decision making progress.

#### **FCCB Investments and green growth**

3. Increased inclusive and gender responsive green public and private sector investments and deforestation-free livelihoods. This will include investment in small and large scale renewable energy projects and climate proofing of critical infrastructure in Z- this component is EIB CONFIDENTIAL.

# **NATIONAL CONTEXT**

Host of one of the world's largest native forest and biodiversity, endangered from:

- Weak governance
- Poor monitoring and enforcement of regulations
- Logging
- Extractive industry

#### **Challenges:**

- High level of gender inequality and gender based violence
