Geographic coverage: entire African continent: actions implemented at continental, regional and (multi-) country level

TEI engagement - around three areas of work:

- Develop EU common messages on AfCFTA
- Strengthen EU coordination on AfCFTA and joint strategic dialogue (continental, regional and national level, PANAF expert group)
- Provide support to the AfCFTA under the Team Europe umbrella. Example: Team Europe Technical Assistance Facility to support AfCFTA

Negotiation ownership and management of the AfCFTA agreement:

- Completed and successful AfCFTA negotiation
- Strong and improved ownership, institutional capacity building

AfCFTA agreement rules and related reforms: enabling Policy, legislative and Regulatory environment Thematic areas and future contributions from the Commission and EU MS:

- Adoption of common and harmonised Rules of Origin (DE, EC, FR, PT, SE)
- Liberalising and facilitating Trade in Services: policy negotiation, regulatory alignment, solid domestic regulations (DE, DK, EC, PT, NL)
- Sanitary and phyto-sanitary (SPS) measures: standards, SPS governance system (DE, EC, FR, SE, NL)
- Technical Barriers to Trade (DE, DK, EC, PT, SE)
- Trade facilitation (DE, EC, FI, FR, IE, NL, PT, SE).
- Competition: transparent and fair policy (DE, DK, EC, FI, FR).
- Investment: regulatory framework (DE, DK, EC, PT).
- Intellectual Property Rights (DK, EC, FI, FR, NL)
- E-Commerce and Digital Single Market: SMEs and women (DE, EC, FR, SE, NL).
- Cross-cutting themes: support to green transition, private sector, youth and women (DE, DK, EC, FI, FR, NL, IE, SE).

KEY DELIVERABLES

- 1. Set up and operationalisation of the TEI Technical Assistance Facility to the AfCFTA (TAF AfCFTA), in support of trade and economic integration matters related to the effective implementation of the AfCFTA
- 2. Development, launch, and operationalisation in July 2022 of the AfCFTA e-tariff book, in partnership with WCO,
- 3. 2 programmes adopted to support Market Access and Quality Infrastructure and to launch of Study on Economic Integration progress towards the Customs Union
- Capacity building for standardisation to enable active participation of African National Standardisation Bodies (NSBs) in international standardisation organisations such as ISO and IEC and of their national governments in ITU.
