- Implementation of the "Just Energy Transition Partnership", alongside focus on greening municipalities and reskilling those who lose their job due to the transition.
- Development of Green Hydrogen and Critical Raw Materials Value Chain.
- Strategic corridor Durban-Lusaka (with eventual extension to the Democratic Republic of Congo).
- Digital Connectivity: subsea cable(s) linking Europe to Africa (Orange) and proposal for a terrestrial link with South Africa (Nokia).

NATIONAL CONTEXT

South Africa is home to 15% of the world's marine species, 10% of plant species, 7% of reptile, bird and mammal species.

South Africa is the world's 14th largest greenhouse gases emitter

Afrobarometer: 54% of South Africans never heard of climate change, only 52% believe it needs to be stopped

Government policies:

- National Adaptation Strategy (August 2020)
- Low GHG Emission Development Strategy submitted to UNFCCC (September 2020)
- National Waste Management Strategy (September 2020)
- Presidential Commission on Climate Change and Just Transition (set up September 2020)
- RSA updated National Biodiversity Framework (November 2020)
- NCDs updated (November 2021)
- Just Transition Framework (May 2022)
- Climate Bill (Expected 2023)


