PILLAR 1: CONSTITUTIONAL RE-VIEW,TRANSITIONAL JUSTICE AND JUDICIARY REFORMS:

- Ongoing legislative reforms
- Reforms triggered by the new Constitution
- Recommendations from the Truth, Reconciliation and Reparation Commission (TRRC)
- Support the role of CSOs (women and youth) in the democratic reforms and to Human Rights
- Support to other democratic transition building-blocks: National assembly, NHRC, press, etc
- Legal and judicial capacity building
- Twinning with a MS Ministry of Justice

PILLAR 2: SECURITY SECTOR REFORM (SSR):

- Training opportunities in or outside the security forces (ITC-YEP)
- Modernizing working conditions for a limited number of police staff (EU, GIZ)
- Specialized expertise for the steering of the process (EUfunded DCAF project)
- Immigration services and police capacities building in countering migrant smuggling and human trafficking

PILLAR 3: DEEPENING THE EU-GAMBIA MIGRATION PARTNERSHIP:

- Regular migration pathways (visa issuance, better involvement of the diaspora, circular mobility, increasing the amount of official remittances/ decreasing their cost, and increasing the number of scholarships)
- Trainings and job creation (revival and diversification of the tourism sector+ agro-processing)
- Expand the social protection scheme (e.g. targeting women)
- Synergies with the Regional TEI on migration

PILLAR 4: PFM, DEBT MANAGEMENT, DRM, FIGHT AGAINST CORRUPTION:

- Support to StateOwned
- Enterprises (SoEs)
 Transparency and sustainable management of natural resources

- 3. Security sector reform: security aparatus fit for purpose and trustworthy and modersination of several police stations.
- 4. Migration: a structured dialogue on migration issues.

- Successfully accompany the country in its transition from an autocratic regime to a stable democracy where the rule of law applies and human rights are respected, and that engages positively in the multilateral, rules based global order
- EI on Good Governance and the TEI on Green Gambia cross-fertilize one another, notably on the legislative aspect
