between the European Union and Guyana

Conclusions of the first Political Working Group





1. Introduction

The European Union (EU) and the Cooperative Republic of Guyana (Guyana), hereinafter 'the Partners' concluded in November 2022 a Memorandum of Understanding (MoU) for a **Forest Partnership**. The Forest Partnership reflects their **shared vision** for a holistic and integrated approach to forests implemented on the basis of **formal strategic dialogue and policy cooperation bilaterally and in the international arena.** In this context, the Partners launch a partnership, hereinafter "Forest Partnership", in the area of protection, restoration and sustainable management and use of forests aimed at:

- i) ENHANCING the role of Guyana's forests in sustainable and inclusive national development, and
- ii) ADDRESSING challenges related to deforestation, forest degradation, climate change and loss of biodiversity

In order to operationalise the MoU, the Partners undertook to jointly agree on quantified **targets**, develop a **Roadmap**, and institute the **Working Groups**.

2. Targets

The special role of **investments** in rolling out the workstreams towards achieving the objectives is highlighted as is the pertinence of international **finance** motivated by climate and biodiversity actions.

The Partners agreed to lay out a set of **targets** to be reached **by 2030** to help sustain momentum and steer action towards the achievement of the objectives set in the MoU, as well as facilitate the mobilization of appropriate resources and attract the necessary investments:

- (1) Increase the area of protected, restored or sustainably managed forests:
 - Maintain Sustainably managed forests: 12.5 million ha
 - Expand Protected & Conserved forests: 30% by 2030 of terrestrial and marine spaces
 - Increase Restored forests: 200,000 ha
- (2) Increase the number of forest-related decent jobs by at least 8%
- (3) Maintain the annual rate of deforestation of natural forests: ha/y deforestation below 0.1%

The implementation will be guided by a **workplan** (outlining baselines, risks/challenges, timelines, associated actors and financial resources). This will serve as the tactical tool to help ladder up to the attainment of the objectives and targets.

The Roadmap

With the quantified targets in mind, the Partners agreed to develop a Roadmap, structured around the four key workstreams of the Partnership with concrete actions, milestones and associated responsibilities being identified at this stage to allow a full exploration of investment opportunities in the course of implementation. The special role of investments in rolling out the workstreams towards





achieving the objectives is highlighted as is the pertinence of international climate and biodiversity finance. The Roadmap is set out in Annex I.

The Roadmap was developed **jointly** by the Partners (*and in consultation with relevant stakeholders*) in the course of six (6) months from the signature of the Forest Partnership MoU. It was **endorsed** via feedback from the Ministry of Natural Resources and the Technical Working Group on 16 June 2023.

This Roadmap represents the **operational arm** of the Forest Partnership with the purpose of advancing its vision and deliver development impact for Guyana in line with the Low Carbon Development Strategy 2030. The Roadmap is firmly anchored in the Team Europe approach and further underpinned by strategic EU initiatives including the European Green Deal and the Global Gateway.

The Roadmap is a **living document** with regular reviews to ensure effectiveness, efficiency, feasibility and implementability. The Political Working Group will guide and steer its implementation and address proposals by the Technical Working Group towards the fulfilment of the aims and objectives of the Forest Partnership. The Technical Working Group will on the basis of the Work plan monitor and evaluate progress, identify opportunities for additional actions and investments as well as options to tackle challenges and mitigate unintended consequences.

4. Working Groups

In the context of the development of the Roadmap, the **composition of the Political Working Group** (PWG) was agreed between the Partners to include: the Vice President and/or Minister of Natural Resources, other representatives of the Government, and the Head of Delegation of the EU to Guyana and or other representatives and Member States of the EU.

The composition of the **Technical Working Group** (TWG) was agreed to include representatives from the Ministry of Natural Resources, the Guyana Forestry Commission (GFC), the National Agricultural Research and Extension Institute (NAREI), the Guyana Geology and Mines Commission (GGMC), the Protected Areas Commission (PAC), the National Toshaos Council (NTC) and the Guyana Manufacturing and Services Association (GMSA). The TWG is also comprised of the Head of Cooperation and or other representatives of the EU Delegation to Guyana.

The Partners also agreed on the working modalities of the Working groups (Annex II).

Annex II

WORKING MODALITIES of the

Working Groups established under the Forest Partnership between the European Union and the Cooperative Republic of Guyana

Role and responsibilities

- 1. The Political Working Group hereinafter "PWG", established pursuant to the Memorandum of Understanding on a Forest Partnership between the European Union and the Cooperative Republic of Guyana hereinafter "Forest Partnership" will oversee the management and implementation of the Forest Partnership and ensure the effective dialogue and cooperation between the Partners in this context.
- 2. The PWG will guide and steer the implementation of the Roadmap, address proposals by the Technical Working Group towards the fulfilment of the aims and objectives of the Forest Partnership.
- 3. The PWG will address any issues that may arise in relation to the interpretation and implementation of the Forest Partnership and facilitate their resolution in good faith and in accordance with the context, purpose and objectives of the Forest Partnership.

Chairmanship

- 4. The PWG will meet at least twice a year.
- 5. The PWG will be jointly chaired by the Vice President and/or the Minister of Natural Resources of Guyana and the Head of the EU Delegation to Guyana. The Chairpersons may arrange to be represented by alternates who will exercise all their rights.

Technical Working Group

- 6. The PWG will be assisted by a Technical Working Group, hereinafter "TWG".
- 7. The TWG will be chaired jointly by the Permanent Secretary of the Ministry of Natural Resources and the Head of Cooperation of the EU Delegation to Guyana.
- 8. The tasks and responsibilities of the Technical Working Group will include:
 - i. Assessing the roadmap structure
 - ii. Developing technical content for the roadmap
 - iii. Coordinating the development of technical proposals for FP road map implementation
 - iv. Reporting on progress to the Political Working Group
 - v. Ensuring active stakeholder engagement and participation where required in roadmap activities

9. TWG composition

The members of the TWG will comprise representatives from the different government agencies, civil society and private sector involved in the implementation of the roadmap, in their respective technical capacities.

The Ministry of Natural Resources will designate representatives of the TWG on behalf of the Government of Guyana and upon agreement with the EU.

Sub-groups may be created according to the needs of the different work streams of the roadmap.

10. TWG coordination

The TWG will be co-chaired by the Head of Cooperation of the EU Delegation and the Permanent Secretary of the Ministry of Natural Resources. The TWG will convene on a quarterly basis as per the Forest Partnership MoU. In addition to the coordination and general implementation oversight of roadmap, the TWG will provide advisory support and guidance to the Political Working Group, including where necessary through briefings and reports, on a needs basis and in preparation of the biennial meetings.

Transparency

11. The PWG and the TWG will ensure that their work is transparent and that all relevant information about its work is made available to the public.







Representation

12. The Parties will notify each other in writing the list of its representatives to the PWG and TWG.

Official communications

- 13. The representatives of the Partners responsible for official communications on the implementation, dialogue and cooperation of the Forest Partnership, including in relation to the PWG and the TWG will be:
 - For Guyana: the Permanent Secretary of the Ministry of Natural Resources
 - For the EU: the Head of the Cooperation of the EU Delegation to Guyana.

Meetings

- 14. The meetings of the PWG or TWG may be held physically or by videoconference.
- 15. A provisional agenda for each meeting shall be drawn up jointly by the Partners and agreed by the Chairpersons no later than 1 week before the beginning of the meeting unless otherwise agreed.
- **16.** The agenda will be adopted by the PWG or TWG at the beginning of each meeting. Items other than those appearing on the provisional agenda may be included if the Partners agree.
- 17. Draft minutes of each meeting shall be drawn up jointly by the Partners or as designated by them. The minutes shall be approved by the Partners at the end of the meeting as "Aide-Memoire".
- 18. Unless otherwise decided, the meetings of the PWG or TWG will not be public.
- 19. Information or documents considered as confidential under national laws and regulations of a Partner will be treated as confidential.

Participation

- 20. The Chairpersons of the PWG or the TWG may agree to invite to their respective meetings where appropriate, private sector actors, social/non-state partners, local communities, Indigenous Peoples, youth, women, international public organisations, interested financial institutions, academia, research institutions and/or donors.
- 21. The invited stakeholders will notify their representatives as requested in the invitation.

Observers and Experts

22. The Chairpersons of the PWG or the TWG may agree to invite observers and experts to their respective meetings on an *ad hoc* basis and in relation to specific subjects.

Facilitation

23. The Partners will agree on the need, role and responsibilities of a Facilitator to accompany the implementation of the Forest Partnership and the functioning of the PWG and TWG.

Expenses

Each Partner will cover any expenses it incurs as a result of participating in the meetings of the PWG or TWG.
