Action 1:

“Develop an inclusive, sustainable and resilient economy, stimulated by innovations and investments at decentralised level”



1:

Develop a Comprehensive National Decarbonisation strategy that includes green financing tools and financial match-making with the private sector.



2:

Develop a pipeline of EU investment (EIB, GIZ, KfW, AECID, AFD) projects to support green infrastructure and green -efficient services at a local level.



3:

Build scalable pilot initiatives at local level that tackle chronic child malnutrition and ensure access to clean water in the long term.




