Key milestones in the EU-NZ relationship

EU-NZ FTA enters into force - 1 May 2024

The EU-NZ free trade deal has officially gone live. It brings new trade opportunities, from traditional tariff lifting to creating potential for cutting edge collaborations.

NZ exporters benefit immediately from 91% duty-free access immediately, rising to 97% after seven years.



To celebrate the entry into force, Minister for Trade, Hon Todd McClay and the European Union Ambassador Lawrence Meredith held an event on 15 May with Ministry for Foreign Affairs & Trade (MFAT), NZ Trade & Enterprise (NZTE) and NZ Story in Auckland.

Europe Day celebrations in Wellington

On Europe Day, 9 May, the EU celebrates its achievements of unity and prosperity, commemorating the signing of the Schuman Declaration in 1950. Deputy Prime Minister and Foreign Minister the Rt Hon. Winston Peters held a Europe Day celebration at Parliament to mark the occasion, to celebrate the strong partnership between the EU and NZ. <u>He underlined</u> the strong values shared and the importance of upholding the rules-based international order, anchored in democracy, rule of law and protection of human rights.

Ambassador Lawrence Meredith thanked New Zealand and emphasised New Zealand & EU solidarity with Ukraine as an example of the shared values cited by the Foreign Minister, as well as the opportunities created by the EU-NZ FTA.

European Union at Fieldays Hamilton June 2024

FTA events across New Zealand

Together with the Ministry for Foreign Affairs & Trade and New Zealand business partners, the EU Delegation to New Zealand organised a regional roadshow of events to promote and inform about the FTA in Tauranga, Auckland, Christchurch and Wellington.

The events gave opportunities for exporters to learn more about how they could leverage the benefits of the FTA. More FTA events will take place further in the year and 2025.

A new regulation prohibiting the placing on the EU market of all products made with forced labour has entered the final stages of the legislative process. The European Parliament has given its final approval in April 2024. The text must now get final formal approval from the Council which is expected in Q4 2024. Application will start three years after the final adoption of the regulation.

The draft regulation is based on international standards and will apply to all products manufactured in the EU for domestic consumption or export, as well as imported products.

Suspected use of forced labour may be investigated and, if proven, products will have to be withdrawn from the market. Attention will be given to products coming from areas with a high risk of forced labour, including State-imposed. If forced labour is eliminated from the supply chain, products may be allowed back on the market.

Horizon Europe Developments

Strong start after one year of New Zealand participation in Horizon Europe

New Zealand has had strong results since it joined Horizon Europe just over a year ago. Currently, 13 out of 54 applications involving New Zealand researchers have been successful. This translates to a high 24% success rate. One of the exciting features of Horizon Europe is that it is open to a diverse range of actors, from universities to business to city councils for instance.

New Zealand entities engagement encompass 126 partners across 40 countries. The 13 successful projects have been awarded around \$218 million in total funding, with \$9.9 million allocated to New Zealand partners involved, with a further \$4.7 million top-up from the NZ Ministry of Business, Innovation and Employment (MBIE).

Expansion of the group of Horizon Europe associated countries

On 3 July, Canada joined the growing group of non-EU countries who have associated to Horizon Europe. 19 countries are now associated. Formal negotiations to associate to Horizon Europe were recently concluded with the Republic of Korea. Negotiations are ongoing with Switzerland, while preparatory talks are taking place with Japan and Singapore.

On 13 June, the New Zealand Ministry of Transport, representing the 11 agencies of the New Zealand Maritime Security Oversight Committee signed a partnership agreement with CRIMARIO (Critical Maritime Routes Indo-Pacific).

EU adopts 14th sanctions package against Russia for continued illegal war against Ukraine

On 24 June the Council adopted the 14th package of sanctions against Russia. The new package responds to the needs and findings on the ground, and tackles enforcement issues. As Russian aggression against Ukraine continues, the EU remains determined to keep acting to further reduce Russia's sources of revenue and capacity to wage war. These measures send a clear and strong signal of EU unity and of our support to Ukraine and its people.

Latest developments on Green Deal

Adoption of the Corporate Sustainability Due Diligence Directive: Following adoption by the Parliament in April and the Council in May, the directive on corporate sustainability due diligence was published early July in the EU Official Journal. Member States will have two years to transpose the new rules into their national laws. One year later, the rules will start to apply to companies, with a gradual phase-in between 3 and 5 years after entry into force.

The aim of this Directive is to foster sustainable and responsible corporate behaviour. It seeks to anchor human rights and environmental considerations in companies' operations and corporate governance.

EU Digital Identity Regulation sets model for citizen engagement with the online world

On 21 May, the Digital Identity Regulation entered into force. The new legislation will empower EU citizens with a digital identity wallet, enhancing their online engagement with greater ease and security.

The wallet will be a mobile app enabling users to identify themselves to public and private online services, all over Europe. In addition, users will be able to store, present and share digital documents (everything from university diplomas to train tickets) as well as electronically sign or seal documents.

The strengthened EU-Aotearoa relationships mean Kiwis could benefit from the EU's advancements in digital identity and privacy.
