Jonathan Van Meerbeeck is Team Leader for Democratic Governance at the European Commission – Directorate General for International Partnerships. He previously worked as Team Leader for Human Rights and in the EU Delegation to Paraguay, and led the management of regional programmes in Africa. Prior to joining the EU institutions, Jonathan was as project officer at the International Centre for Migration Policy Development.

Markus Handke studied law in Germany and in France.

Having worked for a German business association, he joined the European Commission in 2004, focusing on the programming and implementation of international cooperation programmes in several regions. He was posted in three Delegations over his career, in Sierra Leone, Haiti and recently Uruguay. Since September 2024 he has coordinated the Team Europe Democracy Initiative.



Update on Grants for Action-Oriented Research

The TED Initiative launched a call for proposals for action-oriented research, open to partner organisations from 18 focus countries, which closed on 12 December. We are pleased to share that we received 131 applications, indicating the significant interest and demand for resources in the field of democracy support. In the coming month, we will work with Member State representatives and our core stakeholders to review the applications and shortlist up to four candidates who will receive funding to implement their projects. We look forward to updating you on the selected projects in the first newsletter edition of 2025.

Starting on 1 January 2025, Poland will take on the presidency of the Council of the European Union for the second time, overseeing its work for a six-month term and joining the presidency trio with

Denmark and the Cyprus. With a strong focus on resilience and international cooperation, Poland's presidency will address key global challenges and priorities, leveraging its leadership to promote stability, good governance, and inclusive development.

Poland's agenda is rooted in building resilience by enhancing crisis preparedness in partner countries through healthcare, education, strong institutions, and civil society engagement. The presidency will place a significant emphasis on fostering democracy and the rule of law, addressing democratic backsliding, and safeguarding civic space across the EU and beyond. Deepening international partnerships will also be a cornerstone of Poland's efforts, with priorities including supporting Ukraine, implementing the Samoa Agreement, and addressing global humanitarian crises.

People-Centered Justice: TED launches Rule of Law Clinics



The TED working group on “Rule of Law and Access to Justice” has the key objective for the period 2024-2025 to “enhance the understanding on people-centred justice (PCJ) and its application in programming”. It organises a series of Rule of Law clinics on PCJ with a focus on tailoring justice interventions to meet specific needs of local populations, ensuring accessibility and inclusivity. These clinics are co-convened by the working group's thematic leads and network members, providing a space to share insights, build capacity, and promote innovative approaches to justice programming.



TED Rule of Law Clinic on People-Centered Justice Programming

On 24 October 2024, TED's Rule of Law Clinic explored people-centered justice, focusing on data-driven approaches and real-world applications. With insights from global experts and case studies from Ethiopia, Kenya, and Nigeria, the clinic highlighted the importance of evidence-based solutions, legal literacy, and adaptive funding to create justice systems that meet the needs of individuals.

TED Rule of Law Clinic on Customary, Informal and Community Justice Services

Building on the first clinic's focus on data-driven solutions, the second TED Rule of Law Clinic examined customary, informal, and community justice systems. Discussions covered challenges like legitimacy and gender concerns, while exploring context-specific strategies to strengthen collaboration and justice services globally.

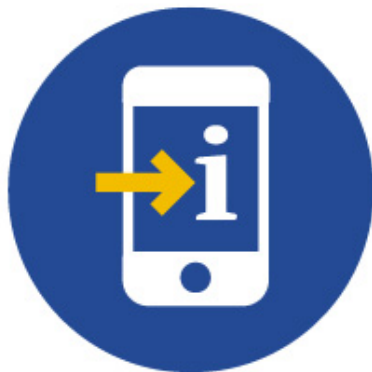

TED Will Support Guatemala with Electoral Reform and Safeguarding of Civic Spaces

Starting in January 2025, TED will support our partners in Guatemala with two key activities. The first focuses on developing a roadmap for electoral reform steps, building on the recommendations of the EU Electoral Observation Mission. This collaboration aims to identify joint support activities that can be implemented by the EU and Member States to strengthen democratic governance in Guatemala. The second engagement involves an in-depth analysis to increase civic space involvement in national reform processes, with a particular focus on the justice sector and open government reforms.



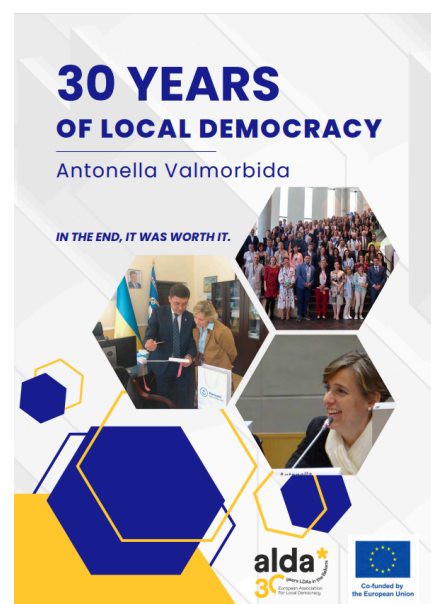

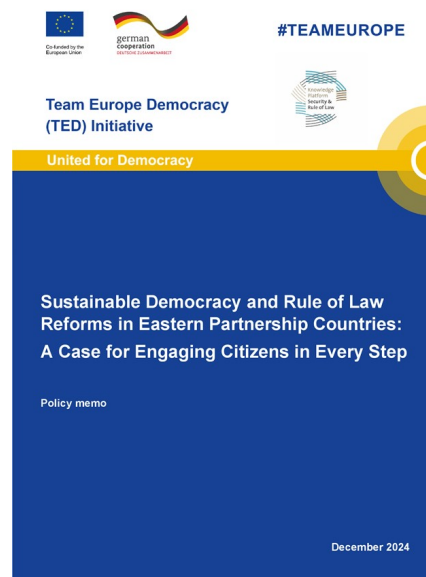


Reforms in Eastern Partnership Countries

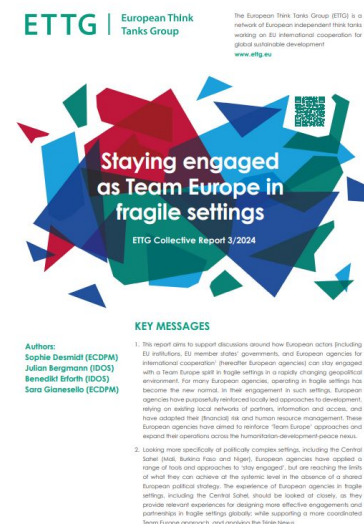


Staying Engaged as Team Europe in Fragile Settings

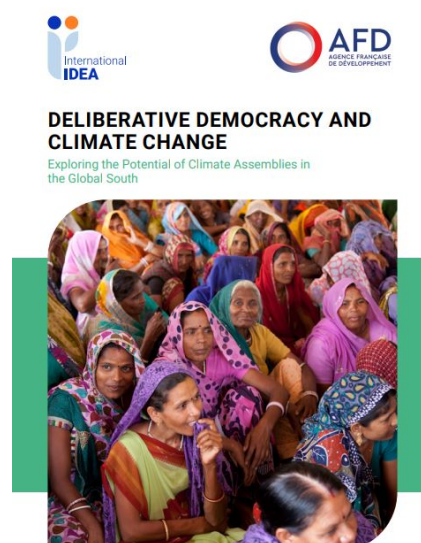
