



Title of session: Financing for Development in the framework of the post-2015 agenda

Background:

As part of the follow-up of the International Conference on Financing for Development (Monterrey, 2002 and Doha, 2008), of Rio+20 (2013) and the current debate on the Post-2015 Development Agenda, the UN will hold the *3rd International Conference on Financing for Development* in Addis Ababa, Ethiopia (13 - 16 July 2015).¹ The objective of this conference is to reinvigorate the Monterrey Consensus and define "a comprehensive financing framework for sustainable development" to support the implementation of the UN post-2015 development agenda. The Conference will result in an inter-governmentally negotiated and agreed outcome, which should constitute an important contribution to and support the implementation of the post-2015 development agenda.

FfD looks into a number of areas that are relevant to all countries, from the broader global issues such as economic governance and external debt to the more concrete such as innovative forms of finance and capacity development. Several organizations have looked into both the available data about financial instruments and trends (including ODA, but also direct investments, remittances, tax evasion, illicit financial flows, etc.) and the rationale for linking those with traditional and new development policies, options and instruments.

In February, the European Commission (EC) published a Communication *Global Partnership for Poverty Eradication and Sustainable Development After 2015*², which lays out EU positions ahead of the third Financing for Development (FfD3) Conference, the Post-2015 Summit, and the 21st session of the Conference of the Parties (COP 21) to the UN Framework Convention on Climate Change (UNFCCC).

The EU is promoting an integrated view in which the economic, social and environmental dimensions of development are supported by the Means of Implementation (MoI), meaning both the financial resources and an enabling policy environment that will aid the

implementation of the Sustainable Development Goals (SDGs) to be finalized in September 2015 at the UN. As such, the outcomes of the FfD meeting in Addis and the post-2015 agenda should result in one single framework.

The communication identifies actions in key areas of proposed implementation: an enabling and conducive policy environment at all levels; capacity development; mobilisation and effective use of domestic and international public finance; stimulating trade to eradicate poverty and promote sustainable development; driving change through science, technology and innovation; mobilising the domestic and international private sector; harnessing the positive effect of migration; and ensuring monitoring, accountability and review.

Objectives:

- Share reactions of PFD members to EC Communication
- Understand actors' views and priorities on means of implementation (Mol)
- Develop key messages for further use in FfD discussion fora

Expected results:

- Better understanding of actors' perspectives and priorities on Mol and FfD
- Core messages to influence global fora and share within PFD member networks

Methodology:

Working groups:

1. **Infrastructure of public goods and social services (including the local level).** This session will discuss the role of public goods and social infrastructure, understood as the mix of facilities, places, spaces, programs, projects, services and networks that maintain and improve the standard of living and quality of life in a community.

 - What aspects of the presentations resonate with your own best practices in developing social infrastructures, and particularly in access to basic services, at local level?
 - What combination of factors promoted this best practice?
 - What are the key implementation issues?

 - What are the key bottlenecks/challenges you/your constituencies/your community face in developing public goods and social infrastructure, and particularly in access to basic services?
 - What is the role of different actors in overcoming bottlenecks to financing for local governments?
 - 3) Elaborate core messages and identify what is missing in the post-2015-related discussions
 - What is missing or has not been given adequate attention?
 - What key messages are you taking to upcoming global meetings?
2. **Innovative sources of financing:** Additional financial resources are clearly needed to accompany the post-2015 agenda and, although new alternatives of financing are often referred to, how easy is it to develop and subsequently access those sources of finance?
 - 1) Reflect on messages
 - Are you aware of best practices? and how can you or have you benefit(ed) from them?
 - 2) Highlight priorities and interconnections between SDGs, Mol and FfD.

- What sources of financing are most vital to achieve change/SDGs at local/regional/global levels?
- What are the main bottlenecks for accessing these sources of financing?
- What are the crucial aspects which could facilitate access to and use of financing in your experience?

3) Elaborate core messages and identify what is missing in the post-2015-related discussions

- What is missing or has not been given adequate attention?

3. The **Partnerships for Development** (new partnerships, global, how effective, how to involve all stakeholders, including the private sector). The use of more cooperation in general and partnerships in particular has multiplied in the last two decades and is likely to continue, complementing the role of traditional players (governments, agencies, international organizations).
