### Areas covered by technical, financial and policy advisory assistance

The Water Facility's scope of work encompasses the entire spectrum of the Water Action Agenda<sup>1</sup> and SDG6: Ensuring availability and sustainable management of water and sanitation for all. The Facility provides comprehensive support on technical, financial, and policy aspects in the following key areas:

1. Sustainable management of the resources to secure water flows and aquifer, economic investments, biodiversity, and to ensure social uses and mainstream water in other sectors.

2. Water for Peace and Security, regional and multi-countries cooperation at the basin level to identify water-related security risks, promoting stakeholder dialogue to increase joint understanding of shared water resources, identify actions that can be taken and resolve conflicts.

# Transboundary

3. Access to Water, Sanitation and Hygiene (WASH) services with a focus on vulnerable and marginalized populations including technical and financial innovative and nature-based solutions<sup>2</sup>.

- **4. Climate Change and Disaster Risk Reduction** related actions and promoting a Nature Based Solutions (NbS) approach.
- **5. Opportunities to access finance** include blended finance, public and private investments, and partnerships with EU companies, all tailored to your specific intervention level: from water resources management to WASH services provision levels.
