

She is PI of the EU project "Migration and Displacement Action Plan for Sub-Saharan Africa (MAPS) Developing policy-oriented research on Migration and Displacement in the Sub-Saharan Region. She served as expert consultant for several national and international institutions, such as United Nations, UNESCO, Council of Europe, Italian Ministry for Foreign Affairs, Italian Ministry of Interior. She currently serves as a member of the UNESCO Liaison Standing Committee of the World Council for Comparative Education Societies (WCCES).



**ALFREDO ALIETTI** University of Ferrara

Associate professor of Sociology and Urban and Territorial Sociology at the University of Ferrara, Department of Humanities. He was a member until 2024 of the steering committee of the Research Network of European Sociological Association 31 "Racism, Anti-Semitism and Ethnic Relations". He is director of the Centre for the Development of International Cooperation of the University of Ferrara, co-director of the Laboratory of Urban Studies of the Department of Humanities. He is part of the Ecology, Politics and Society Italian network of scholars. His main topics of research are racism, discrimination, interethnic coexistence in urban contexts, urban policies, social resilience, environmental racism and environmental migration.

Professor of Demography and Population Studies at Kabale University. I hold a PhD in Popu-lation Studies, a Master's in Demography, and a Bachelor of Social Sciences majoring in Economics and Sociology. I have undertaken advanced training in Modeling Demographic Dynamics, Sexual and Reproductive Health, including HIV/AIDS, Monitoring and Evaluation of Population and Health programmes in diverse contexts, and the application of Quantita-tive and Qualitative tools in data generation and analysis, demonstrating my deep tech-nical competence in data acquisition and analysis. I worked on several research projects sponsored by MLGSD-Uganda, UNI-CEF, UNFPA, UNDP, IOM and bilateral projects of USAID, contributing to understanding the impacts of forced displacement of nearly 2 million people in Northern Uganda during the LRA insurgency and other vulnerable population groups on topics that include HIV/AIDS, Sexual and Reproduc-tive Health, Nutrition and well-being of children, and Gender Based Violence.

His main research interests include modeling and control of deterministic nonlinear systems, online and offline data assimilation techniques, identification of nonlinear systems, and nonlinear optimization problems. He is the co-funder of the DATINNOVA startup.

For over twenty years, she has worked on socio-spatial inequalities and multilevel public policies on housing and migration as researcher and policy advisor to major European programmes and international organizations. Programme Expert for URBACT (2004–2023), she advised hundreds of municipalities on housing, migration, education, culture, and urban regeneration. She contributed to EU Urban Agenda Partnerships on Affordable Housing, Urban Poverty, Migrant Inclusion, and Culture, and evaluated New European Bauhaus projects. Ph.D. student in Mechanical and Industrial Engineering. Her research focuses on the impact of climate change on migration trends, emphasizing socio-economic analysis and modeling to support decision-makers. She collaborates on sustainable development projects aimed at enhancing resilience to climate change. She is the co-funder of the DATINNOVA startup.

Deputy Director General of Scientific Research; Ministry of Higher Education, Scientific Research and Innovation, Guinea. He is a lecturer-researcher and research administrator. His research focuses on issues related to democratization in Africa and identity challenges. He favors multidisciplinary and cross-cutting approaches. He has taught several courses in Political Science at French and Guinean universities.

Research fellow in Demography at Sapienza University of Rome. His main research focuses on the gender gap in health and survival, examining the contributions of age and causes of death to the gender gap in life expectancy, as well as the social and behavioral risk factors that may increase or decrease the gender gap in healthy life expectancy. His research also explores the spillover effects of state pension reforms on (healthy) work histories, investigating trends and inequalities – such as health, socio-economic disparities, and working conditions – that contribute to changes and differences in (healthy) working life trajectories.

PhD in Demography working at Sapienza University of Rome. Her research focuses on migration and integration, investigating voluntary and forced mobility aspirations and realizations, migrants' well-being, economic and social inclusion, emerging aspects such as return and environmental displacement, policies and communication on migration issues. In her studies, she adopts an interdisciplinary approach leveraging quantitative and qualitative methods, spanning from texts' analysis, survey data analysis, to ethnographic interviews and focus groups.

Professor of Statistics at the Department of Mathematics and Statistics at the University of Dodoma. His research interests include medical statistics, migration and displacement, statistical inference, statistical process control, applied Statistics. He was recognized as a world scientist in the AD Scientific Index 2025.
