**POLIMP - Mobilizing and Transferring Knowledge on post-2012 Climate Policy Implications** is a research project funded by the European Commission, under the 7<sup>th</sup> Framework Programme for Research, which initiated in May 2013 and has a duration of 36 months.

POLIMP explores, for different policy and decision making levels, knowledge gaps and needs about implications of possible directions of EU and international climate policies. The above focus on the policy and decision makers, as well as the actors who influence them, such as businesses, researchers and NGOs. Subsequently, POLIMP covers these gaps with:

- ✓ Knowledge packages derived from stakeholder consultation,
- ✓ Analysis of climate policy decision at national, EU and UN policy levels, and
- ✓ Review of ongoing research.

The [POLIMP Expert Response Survey Series](#) engages a pre-selected targeted group of stakeholders and experts (Expert Response Group - ERG) on matters relating to EU and international climate and energy policy.

The ERG is composed of **43 stakeholders**, handpicked and invited to participate by the POLIMP partners for their expertise, engagement with topics relevant to the project and tenure in the field.

**Each survey and report is organized into three parts:**

1. **EU Climate 'Barometer'** – three recurring questions on a general assessment of the status quo,
2. **Main Topic** – thematic questions linked to the topic of a corresponding Webinar,
3. **"Buzz of the Week"** – question(s) on a relevant climate policy topic currently in the news.

### Key survey results:

- ✓ Experts showed **high confidence** in EU climate policy and **positive outlook** on its economic impact.
- ✓ However, they believed that the international community **may not deliver** on the two degrees target.

ERG comment on the recent legislative proposal for a revision of the EU-ETS adopted by the EC and what impact the reforms could have on the EU meeting its 2030 Climate and Energy targets.

### Key survey results:

- ✓ General outlook **more negative** compared to previous survey.
- ✓ Experts showed a **more pessimistic view** on reaching the two degrees goal and **lower confidence** in the EU making its long-term targets.
- ✓ However, they see **more favorably** the impact on the economy.

ERG comment on the recent changes and possible future developments of the 2030 EU climate and energy governance system.

### Key survey results:

- ✓ The POLIMP experts were **increasingly more pessimistic** regarding the success of long-term climate policy in the EU when it comes to meeting emissions goals.
- ✓ The impact of EU climate policy on the economy was rated **slightly more negative**.
- ✓ There was a **slight increase in optimism** concerning the capacity of the international community to tackle climate change.
