# National dialogues

National dialogues carried out in **13 countries**:

- **Africa** (Burundi, Cameroun, Ghana, Malawi and Tanzania)
- **Asia & Pacific** (Philippines, Tajikistan and Vanuatu)
- **Europe** (Armenia, Portugal)
- **Latin America & Caribbean** (Ecuador, El Salvador and Jamaica).

# National Dialogues

Active **local leadership** by:

- local governments and local governments associations
- in coordination with national stakeholders

Active **participation** of:

- civil society organisations,
- religious organisations,
- academy,
- trade unions
- the private sector

# National Dialogues

Approximately **4,200 participants** from national and local institutions

- 40% of whom represented: minorities, marginalized, people with disability, young people and women.

**Eleven** national preliminary reports have been produced
