Further, as natural resources are intrinsically interlinked, pathways and policies designed to accomplish one SDG may impede progress towards numerous others.

This event will discuss the main findings of the IRP on sustainable use and management of natural resources in the context of the SDGs with the aim of drawing the attention of those involved in the process to several potential policy coherence issues.
