The conference serves as an opportunity for the 'Network on Humanitarian Action' (NOHA) to discuss themes and outcomes of the first ever World Humanitarian Summit (WHS), which took place in May 2016 in Istanbul.

It will focus on a WHS theme of particular importance: safety and protection. Millions of civilians suffer from the consequences of armed conflicts or natural disasters and are often subject to gross human rights violations. They are in dire need of protection. Even though safety and protection have become a central concern in humanitarian settings since the late 1990s with numerous norms and policies having been developed, the practical implementation of the new regime has been far from satisfactory. The need for improvement of this situation was a cornerstone of the WHS. It was declared an 'Action Area' with the aim to "keep people safe from harm by putting protection at the centre of humanitarian action". However, the results of the WHS in the area of safety and protection were heavily criticized and the humanitarian organization MSF even pulled out from the process in protest against an obvious neglect of the issue.
