#### Did you know?

It is estimated that about 1 million Roma<sup>1</sup> live in the Western Balkans, 2.8 million in Turkey and 6.2 million in the EU. Roma are Europe's largest ethnic minority. They face continued exclusion, segregation and discrimination.

The EU's policy on Roma inclusion, integration and empowerment is placed within an EU Framework for National Roma Integration Strategies up to 2020 adopted by the European Commission in 2011. Within that framework, all 28 EU Member States and all 7 candidate countries and potential candidates for EU membership adopted their National Roma Integration Strategies which they now put in practice.

In June 2016, the Commission adopted its annual report on Roma integration that stresses the following as regards the candidate countries and potential candidates:

- Roma integration continues to be a priority in the enlargement process.
- Enough funding must be ensured to carry out integration measures.
- Attention should focus on implementation by local authorities.
- Roma community should be involved in planning, implementation and monitoring.
- Focus on results on the ground to reduce the gap between Roma and non-

	The project activities are concentrated around Prishtina, Prizren, Gjakova, Ferizaj, Mitrovica and Peja universities targeting Roma university students from all Kosovo who are pursuing their academic career in public and privately (Kosovo and Serbian) administered universities.  In this regard, AT operates through its 3 (three) Roma Versitas Student Resource Centers (Prishtina, Prizren and Peja).  Roma Versitas Kosovo Program is the first and the only Program that supports Roma's in registering and finishing university's.

The main objective of the project is to increase the retention and academic performances and graduation rate, while building the advocacy, self-esteem and identity of about 80 Roma full-time students enrolled in tertiary education in Kosovo.

During the current implementation cycle at least 160 Roma university students are expected to benefit from the Roma Versitas (hereinafter RV) assistance, min 80 Roma, students are to receive tutoring assistance per one academic year, at least 40 Roma, high school graduates/freshmen students are expected to receive non-formal peer mentoring, 100 students are expected to participate in 6 thematic academic workshops/training (80 Roma, and 20 non-Roma, students), 20 Roma, students attend foreign language and 20 students' computer courses. It is worth to note that the project beside Roma also offers an opportunity to non-Roma students' as well.

#### **Compulsory project components are:**

 Establishment of the Advisory Board, Roma Versitas Student Resource Center and Library:

The objective of the Component 1 is to establish AB, create a RV student resource centre and to establish a library with most common books.

- Roma Versitas Student Resource Centers (RVSRC), Library and E-Library:
   RVSRC, Library and E-Library enrichment and maintenance in Prishtina, Prizren, and Peja.
  - Academic tutoring scheme;

The objective of Component 2 is to improve the retention, performance and graduation levels among at least 80 Roma full-time tertiary students (Kosovo Albanian and Serbian administered Universities) in Kosovo through provision of academic tutoring.

Provision of Mentoring Services:

The group mentoring for freshmen students will be carried out by mediators. The activity implementation will be carried out by RV Kosovo PM and PO.

#### Additional project components include:

Provision of academic development services;

The objective of component 4 is to ensure supplementary academic support to advance the students' learning capacities. It will help up to 80 full-time students (80 Roma and 10 non-Roma) tertiary students in Kosovo to acquire academic skills necessary for their successful professional development and managing in any sphere of life.

Student Initiatives and Projects- SIP:

The objective of component 5 is to support up to 80 full-time Roma tertiary students in Kosovo to further expand, express, and exchange their academic knowledge and skills in their fields of studies as well as to raise policy issues tackling Roma students or the Roma, community by providing them with small grants to conduct researches and/or debates and discussions.

Self-confidence support and social activities

The activity will be delivered through taking positive examples of the renowned universities in Kosovo. Initially, assessing the needs of specific skills which will raise the self-confidence of the targeted students.

RV Kosovo Program has supported student beneficiaries from different field of studies (Medicine, Economy, Law, Political Science, Public Safety, Architecture, Electro Technics).

In accordance with the grade transcripts of RV students, 84% of students have successfully passed their respective exams.

RV Kosovo Program identified 5 mentors from under graduate students the aim to support freshmen students and inform them for students life, during this period mentors were mentoring a total of 16 freshmen students. All above-mentioned freshmen students have received the necessary support from their respective mentors in accordance to the outlined Terms of Reference.

RV Kosovo Program has developed following academic workshops:

- Academic Writing;
- Time Management;
- · Communication and CV writing;
- Project Proposal Writing & Project cycle management;
- Presentation and Communication Skills,
- Debating and Interview.

Roma Versitas Kosovo Program for its beneficiary students organizes English/German Language course in period of 3 months where 32 students has started the course, 24 of them has completed the course successfully.

In a course of 3 years of the implementation of the RV Program; beside its activities; RV with its students managed to: a)Participate in Education Fair, inviting the mainstream students to be part of RV; b) Organize public manifestation/protest: In defence of life with dignity for Roma International day; 8th April 2015, with participation of the Roma and non-Roma students and CSOs; c) Seven students got internship at different national and international institutions; d) four students got employment; e) 150 students registered in the public and private Universities; f) Roma Kosovo students database created; g)E-Library and Library was created; h) Participate in the "Dik he na Bister" Roma Genocide Remembrance

Initiative; I)Be part of the first of its kind "RV Summer Camp".

Upon agreement between AT and RV Albania, on May 2016 the first cross-border cooperation activity was organized. Beside implementation of the formal learning activities (academic writing), the program had the opportunity to create space of inter-student socialization across countries and make them learn about each-other, combined with the fact of their own identity and formal way of gaining academic skills.

The purpose of these joint activities was to increase the capacity of students who are beneficiaries of these programs as well as socialization and knowledge of the traditions and culture and Roma identity in Prizren and Kosovo. In this activity participated 70 Roma students from Kosovo and Albania.

Social modules are developed through taking positive examples of the renowned universities in Kosovo. Initially, assessing the needs of specific skills which will raise the self-confidence of the students. RV Kosovo acquired support from institutions for provision of services in sociology and psychology counselling.

AT as a non-governmental organization upon its creation has picked up its mandatory role of implementation of its statutory and founding commitments in alleviation of the plight of Roma, taking into consideration that most of the founders, BoD and the key managerial position are of Roma origin.

The RV Kosovo program takes into consideration the high dropout rate among freshmen students and girls dropout from academic study, thus upon implementation of the program has created the mechanism of support to freshmen students giving priority to girls.

From the year August 2013 up to August 2015 the share of the beneficiaries between males and females were as follow:

26 Males in percentage 58 %

19 Females in percentage 42%.

From September 2015 up to August 2016 the share between males and females is as follow:

33 Males in percentage 41%

57 females in percentage 59 %.
