Did you know?

It is estimated that about 1 million Roma¹ live in the Western Balkans, 2.8 million in Turkey and 6.2 million in the EU. Roma are Europe's largest ethnic minority. They face continued exclusion, segregation and discrimination.

The EU's policy on Roma inclusion, integration and empowerment is placed within an EU Framework for National Roma Integration Strategies up to 2020 adopted by the European Commission in 2011. Within that framework, all 28 EU Member States and all 7 candidate countries and potential candidates for EU membership adopted their National Roma Integration Strategies which they now put in practice.

In June 2016, the Commission adopted its annual report on Roma integration that stresses the following as regards the candidate countries and potential candidates:

- Roma integration continues to be a priority in the enlargement process.
- Enough funding must be ensured to carry out integration measures.
- Attention should focus on implementation by local authorities.
- Roma community should be involved in planning, implementation and monitoring.
- Focus on results on the ground to reduce the gap between Roma and non-Roma.

The issue of respect for children rights and proper implementation of anti-discrimination policies constitutes one of the key recommendations of the EC Opinion in Albania. In particular, the embryonic stage at which the implementation of the Law on Legal Aid and the functioning of the appointed Legal Aid Commission have been boldly evidenced year after year by the EU, as factors hampering access to justice and social benefits for vulnerable groups, such as children and women, victims of domestic violence and discrimination, minorities, in particular the Roma.⁴ More than six years from the adoption of the Law in Albania, little to no impact can be traced and the activity of the Legal Aid Commission remains virtually invisible. Moreover, even the judiciary and administration fees alongside with notary fees are high to be covered by vulnerable families. The child birth registration, namely the legislative and policy frameworks has been significantly improved during recent years, but the implementation of such laws and policies has resulted in an unfinished job and has not lead to the full right of every child being registered and having a name and nationality, especially for Roma children and youth. During two last years, the trend of the vulnerable unregistered children is on the rise. The influence of the economic crises in Greece, and not only, is one of the main factors of Albanians returning back to their country with many returning children who are not registered. Currently, there are more than 450 children who are not registered at birth and who as a result have encountered difficulties in being enrolled in school (based on the data base of TLAS).

In this context, the attendance of kindergartens and schools or other basic services has become more difficult with unregistered children being one of the important categories of Out of School Children⁵. The need for advocating with MOES in developing or updating the provisions for attendance of children who are not registered has come up as a need for aggressive evidence based policy improvement in order to ensure that category of children attends school.

The interventions foreseen under this proposal will work towards filling the gap in ensuring that all children are registered at birth through provision of increased capacity of service providers dealing with child registration, with increasing the awareness and knowledge of the population at risk such as Roma on the benefits and entitlements for registration as well as through ensuring that children identified as unregistered are enrolled in preschool and school.

The activities of this project will be closely linked to the Every Roma in preschool initiative of MOES and UNICEF which aims at ensuring an increased accountability for service providers for the enrolment of Roma children in preschools and later on in school. Identified children who are not registered in preschool and who lack birth registration will be fed to TLAS for ensuring their birth registration and preschool/ school enrolment.

Furthermore, based on the State Legal Aid Commission statistics for 2014, only 169 applications for free legal assistance were received by this Commission, and of these only 140 were accepted as eligible. Of the 140 eligible cases only 29 completed their judicial process and received their final court decision. None of them was a child rights case.

Results achieved of the project (Section 5, criterion 2 of the Contest Rules):

The main aim of the project is to ensure access to social services through birth registration. An unregistered child may be easily victim of labour exploitation, trafficking, discrimination and neglecting, especially when this child belongs to Roma community. When a child is registered other intermediary services such as social programs, welfare, schools, kindergartens, and healthcare are easily accessible. Unregistered children are still an issue to be seriously considered firstly by parents, and secondly from civil office and all child protection units and professionals working with them. The trend of the flux of unregistered children cases is showing that the biggest number is coming from the poor Albanian emigrants or refugees, who live temporarily abroad the country, especially Roma families who frequently travel from one location to another. The target to be achieved in the time frame of 15 months is 260 birth registration cases. Until August 2016 there are open 233 and finished 161. All these Roma children have had the opportunity to access education system, entering schools, kindergarten and benefiting from free healthcare system. TLAS pays all the judicial expenses for all the administrative cases, making us the only NGO in Albania of this type. All Roma Community people have found to us the reliable partner for solving their entire legal problems, especially that of birth registration.

The second result of the project is to improve the knowledge of service providers and Roma community itself to increase awareness on the importance of child registration and all benefits it brings for vulnerable children. Therefore, TLAS has conducted 7 different reach out meetings with different service providers in Albania, civil office workers, social workers, grass-roots organizations workers, in 7 districts, to ensure a large coverage. There are trained 182 service providers in the period of 5 months, improving their knowledge on treating, informing, referring and following up the cases they face in daily work. These persons are now part of the big network TLAS works with, sharing information, referring cases and receiving directly advice or assistance for the unregistered children in a quick way and with low costs.

Street Law Activities are another project which intends to reach the communities face-to-face, to explain to them the importance of child birth registration and to find new cases during these meetings. There were planned 16 activities and until the end of August there are finished 9 of them. **360** Individuals and students are informed during 9 street law activities by TLAS working groups of law students and paralegals for importance of child identity and

other discriminatory forms related to unregistered children.

Direct and indirect activities held by TLAS are always in function of achieving the main goal of the project; Increasing inclusion of Roma children and youth by ensuring first their birth registration, as the main and the most important right of every citizen of any country. By this, we are strongly committed to reduce discrimination and to achieve long-life results.

There are approximately 16 persons engaged to carry out the project. The working group is composed of 9 full-time employees; Four lawyers, Two paralegals, One psychologist, One project Coordinator and One finance officer. Lawyers are responsible of representing the cases in the court, since many of the unregistered children may be register only through court routes.

Paralegals are responsible of solving the cases through administrative procedures. These procedures take less time and it is highly supported by some state structures, with which TLAS has strong cooperation, such as Ministry of Internal Affairs, Ministry of Foreign Affairs, Commissioner for Anti-Discrimination etc.

There are three Intern volunteers, students of Faculty of Law in Tirana, responsible for organizing all Street Law Activities and achieving direct and face-to-face communication with Roma Communities.

Another very important asset of the project is 4 field coordinators. They are young, belonging to Roma Community and a great help, who assist us to refer cases and directly contact the community, discover the children cases and collecting the biggest part of the documentation, bridging TLAS' relations with Roma families, frequently advocating for the importance of child and birth registration, conveying our mission and vision to their peers and all interested parties.

This big group has made possible to handle the large influx of the Roma families, who need our specialized help to register their children, to make them citizen with full rights of our country and to fully benefit from all free social and health services.

The project is intended to benefit both genders. TLAS is serving girls and boys equally in quality and quantity. Thus, in the list of the beneficiaries until the end of August 2016 is easily noticed the balance of boys and girls, 51% females and 49% males. TLAS is assisting all the beneficiaries cautiously considering the gender balance. However, we are lead up by the principle that every person in need should be helped in order to effectively ensure their inclusion in every community. We provide a crucial and safe place for both women and men to come in our premises and ask for our legal aid, listening to their needs despite their gender. This is a main characteristic of our every day job that makes us distinguishable of other NGOs, which may be specialized only in women or in men.
