Did you know?

It is estimated that about 1 million Roma¹ live in the Western Balkans, 2.8 million in Turkey and 6.2 million in the EU. Roma are Europe's largest ethnic minority. They face continued exclusion, segregation and discrimination.

The EU's policy on Roma inclusion, integration and empowerment is placed within an EU Framework for National Roma Integration Strategies up to 2020 adopted by the European Commission in 2011. Within that framework, all 28 EU Member States and all 7 candidate countries and potential candidates for EU membership adopted their National Roma Integration Strategies which they now put in practice.

In June 2016, the Commission adopted its annual report on Roma integration that stresses the following as regards the candidate countries and potential candidates:

- Roma integration continues to be a priority in the enlargement process.
- Enough funding must be ensured to carry out integration measures.
- Attention should focus on implementation by local authorities.
- Roma community should be involved in planning, implementation and monitoring.
- Focus on results on the ground to reduce the gap between Roma and non-Roma.

Education of Roma children is one of the main objectives of the Decade of Roma and alarming situation in the Roma community, define our organization to deals exclusively with the issue of education.

Our main objectives are related to education, the realization, protection and improvement of the existing laws in the field of national minorities and communities, protection of status interests, improving living standards, social and economic situation of the Roma community. CERC initiate and conduct permanent campaign for literacy of Roma children and adults who have not completed primary school.

The specific activity of CERC is informative, with a focus on publishing books and other publications in the fields of education, culture and identity of Roma, the Romani language, history, and in the field protection of human rights in accordance with the law. CERC has specific tasks to organize and animate teachers in primary and secondary schools and other professionals to work on the education of children and youth in the field of Roma language, culture, identity and history.

Overall objective: To ensure the social inclusion of marginalised groups and communities with the strengthening of the Roma culture, identity and active socio-economic integration of Roma into society in Serbia. Encouraging interested young people (especially the Roma minority representatives) to acquire new knowledge will enable creation of intellectual elite that comprehensively examines various aspects of the issue.

Specific objective: The introduction and implementation of programs for the Roma language teaching in primary schools from 1 - 4th grade in Serbia through the enhancement of the employment and raising capacities of young educated Roma.

Until today, we implemented following activities:

- Information and selection of the interested candidates - With support by Roma Information Centre (RIC) and the existing National Council of Roma National Minority (NCoRNM) we informed members of Roma national community, young faculty educated Roma, about attending training courses. In cooperation with Ministry of Education (MoE), we create questionnaires for introduction of Roma language with elements of national culture which are fulfilled in targeted primary schools. Over 100 young Roma with faculty education informed about the training programme. The Project Partners formed and appointed the Committee for Selection of Candidates (CfSoC) which determined the list of required qualifications for attending trainings, such as minimum completed education and knowledge of the language which will be used as a language of instruction during trainings, after which they reached a decision on selected candidates. Out of 62 submitted applications 40 were selected for participation.

- Training program realization is designed to strengthen the capacity of the beneficiaries in the fields of Roma language teaching methodology and to increase their employability through the acquisition practical and theoretical skills. In this sense, the focus was on the development of competences required to achieve (self)-employment and to initiate introduction of the Roma language with elements of national culture in primary schools in Serbia. 45 young Roma with faculty education trained on Roma language, according to the accredited program „Normalization, codification and standardization of Roma language“; the importance of language and language policy; European Roma dialects; Language processes to standardization; The voice system of the Roma language; Review of the literature of Roma language; History of the Roma language; The migration of Roma from the aspect of linguistics; etc. Awarding certificates event for the course Roma language and culture for the participants was organized on 28th September 2016 at the Faculty of Philology, University of Belgrade. Preparation of this activity is communicated with Ministry of Education as the Ministry has entered procedure to adopt Regulation on the plan and program in primary schools.

- Preparation of teaching materials for the Roma language with elements of national culture: ABC book; Reading book I, Reading book II, Picture book and Working books.

- From 40 trained young Roma, 30 of them introduced as teachers of Roma language with elements of national culture in targeted primary schools in Serbia. At least 500 Roma children are interested attending classes on Roma language in targeted primary schools.

Result 1: Young educated Roma additionally trained and motivated to implement the teaching of election programs

- To improve knowledge and skills of future Roma language teachers on the methodology and process of teaching
- To organize accredited training for 40 Roma on the implementation of the teaching elective course

Outputs:

1. Accredited training courses on Roma language with elements of national culture developed and implemented
2. Six accredited trainers hired for training conduction
3. Over 100 young Roma with faculty education informed about the training programme
4. Two meetings of the Committee for Selection of Candidates organized
5. 40 candidates chosen for training participation
6. 40 young Roma with faculty education trained on Roma language with elements of national culture, according to the accredited program „Normalization, codification and standardization of Roma language“.

Result 2: Prepared and issued teaching resources for the implementation of the teaching elective course - the Roma language with elements of national culture

Teaching materials prepared and designed. Next phase is printing/publishing and distribution to all targeted schools and students involved in teaching program of Roma language with elements of national culture.

Result 3: Introduced teachers of the Romani language in the education system of primary schools in 15 pilot cities – is not fully achieved (activities are ongoing)

1. At least 30 teachers on Roma language with elements of national culture introduced in educational system
2. At least 500 Roma children attending classes on Roma language with elements of national culture

Additional efforts were made by CERC and NCoRNM in communication with MoE regarding the new Questionnaires for parents to be fulfilled with the support of primary schools in Serbia. This activity was of great importance as School Administrations are

informed to that subject Roma language should be introduced as elective subject, not as extracurricular activity.

In order to develop and preserve equal treatment of Roma culture, traditions and language, the CERC and National Council of the Roma national minority in Serbia together with members of the council, educational assistants, Roma non-governmental organizations and municipal Roma Coordinators from the Republic of Serbia, has proposed action of the survey of parents of Roma children attending primary school in Serbia interested in introducing an elective subject "Roma language with elements of national culture."

On the basis of following collected data from the parents, we have targeted elementary schools, as well as the number of children:

Number of municipalities: 15 (with several municipalities in Belgrade)

Number of elementary schools: 46 primary schools in Serbia

Number of interested children: 2.570 children.

For now, we don't have precise data on gender structure of the children in the schools. This information will be available to us before the end of the project, when we combine the final lists of children. Our assumption is that this is 50/50.

In accordance to Centre's Strategic Plan, objectives of the organization are as follows:

- Sustainable integration of Roma children in the education system through the introduction of Roma language with elements of national culture in education institutions.
- Creating networks/platforms for improving access to education and quality education of Roma children
- Raising capacities of Centre by promotion of human and material resources.
