Did you know?

It is estimated that about 1 million Roma¹ live in the Western Balkans, 2.8 million in Turkey and 6.2 million in the EU. Roma are Europe's largest ethnic minority. They face continued exclusion, segregation and discrimination.

The EU's policy on Roma inclusion, integration and empowerment is placed within an EU Framework for National Roma Integration Strategies up to 2020 adopted by the European Commission in 2011. Within that framework, all 28 EU Member States and all 7 candidate countries and potential candidates for EU membership adopted their National Roma Integration Strategies which they now put in practice.

In June 2016, the Commission adopted its annual report on Roma integration that stresses the following as regards the candidate countries and potential candidates:

- Roma integration continues to be a priority in the enlargement process.
- Enough funding must be ensured to carry out integration measures.
- Attention should focus on implementation by local authorities.
- Roma community should be involved in planning, implementation and monitoring.
- Focus on results on the ground to reduce the gap between Roma and non-Roma.

Better understanding of decision maker on the role Roma Focal Point, which will help to make sure that strategies and policies are adapted to the needs of the Roma people and build on the lessons learnt at local and regional level. The project aims to mainstream minority rights at the work of policy makers at the local level through the direct engagement of the Roma communities as Roma Focal Point. Project strives to increase the participation of the Roma communities in the local development agenda and to have strategic community development plans implemented in the municipalities of Tirana, Durres, and Fieri. The participants at the roundtable were youth, activists and members of Roma communities, Roma NGOs and other CSOs working on social inclusion, local government, student and lecturers.

Local government by approving Roma youth experiences as FC effectively, will have maximum impact and this is essential for addressing the problems faced by Roma people today.

The main message should be: *It is needed!!! Roma youth participation, should be “inspiring, motivating and empowered”, and easy to understand among others people involved*

The project primary target are:

1. Roma minority group in Albania, particularly:
 - 1.1 Roma youth such as university students and graduates in the disciplines of law, social sciences, economics and humanities;
 - 1.2 Roma young professionals that are interested in work placement and community work;
 - 1.3 Roma community leaders and activists; entrepreneurs.

The project also targets:

2. Policy makers at the local level in Albania as well as non- Roma youth working on issues of minority rights. **Partners in the project:**

European University of Tirana (UET) – leading higher education institution in Albania. UET provides financial and academic support to Roma youth: study scholarships; student advising and mentorship through Student Services, Career and Internship Office and Office for Project Development

Institute of Romani Culture in Albania (IRCA) - very much influenced by services provided at advocacy bodies such as the Italian Institute of Culture in Albania, British Council, Peace Corps Volunteers as well as the career advice, research and documentation centers functioning within universities in Europe and North America, with most of which IRCA initiators have had their own experiences. Combination of volunteer advocacy with education services and recreation activities, has led to establishment of three youth networks: Romani Students' Network, Romani Corps of Volunteers as well as Romani Youth Parliament - Forum. Most of IRCA's activity is also featured “Kanxura”-Radio. **Stakeholders** in the project are: Civil society organizations working on youth issues; Roma and human rights; universities, local and international donors with activities that have a focus and/or interest in human and minority rights in Albania. **This project seeks to mainstream minority rights at the work of policy makers at the local level through the direct engagement of the Roma community as Roma Focal Point.** The project will propose and establish Roma Focal Points (RFP) network and develop some practical guides to prevent discrimination against the Roma community as part of the decision making process at the local level.

1. The project promoted Roma Community rights at the work of policy makers at the local level through the direct engagement of the Roma community as Roma Focal Point.
2. The project established Roma Focal Points (RFP) network and developed some practical guides to prevent discrimination against the Roma community as part of the decision making process at the local level. RFP network on sharing experiences between Roma association and other entities, media professional, lawyer, social services and monitoring activities.
3. The project offered to 25 Roma youth/students an in-depth analysis and development effective of RFP approach of the human rights system in Albania and discrimination against Roma Community;

The project objectives were achieved through the following **activities**:

- 1.1 Coordination meetings with the representatives of local level. (May 2016 - UET Centre – IRCA) Meetings with stakeholders and Roma Youth Community as Roma Focal Points at Municipality of Tirana, Municipality of Durrës and Municipality of Fieri.
- 1.2 Establishment of Roma Focal Point in Municipality of Fieri, Tirana and Durrës. Two Roma Focal Points conducted the Internship in each municipality for 1 month (4 weeks). RFP during their internships assessed Roma Communities rights and express their needs in the municipal level, monitored Roma community access to public services. RFPs have prepared a policy report on monitoring findings.

Organization of two day Seminar/Workshop (23 – 24 June 2016): “Participation and engagement of Roma community in local government”. 25 Roma youth/students together with non-Roma youth, academic staff, representatives of local authorities, Roma community leaders and activists in civil society to exchange experiences, ideas, knowledge on Roma rights and youth and build networks for future cooperation.

Organisation of Round table (24 October 2016)

“Engagement and impact of Roma Focal Points at the local government: Ways to move towards participatory policy making.” During the roundtable the best practices of the Roma Focal Points at Municipality of Fieri, Durres and Tirana were presented as well as recommendations on how to move forward. The round table was attended by 25 young representatives of the Roma community, academic staff, representatives of local authorities and civil society organizations.

Two Roma Focal Points conducted the Internship in each Municipality for 1 month (4 weeks). RFPs during their internships assessed Roma Communities rights and express their needs in the municipal level, monitored Roma community access to public services. RFPs have prepared a policy report on monitoring findings.

Organization of two day Seminar/Workshop (23-24 June 2016): “Participation and engagement of Roma community in local government”

25 Roma youth/students together with non-Roma youth, academic staff, representatives of local authorities, Roma community leaders and activists in civil society to exchange experiences, ideas, knowledge on Roma rights and youth and build networks for future cooperation.

In the framework of the project: “Working together and Joint Forces for Roma youth social inclusion through tailored policies and good practices on minority rights”, UET Centre, in collaboration with the Institute of Romani Culture in Albania and with the support of the Konrad Adenauer Stiftung, Southeast Europe Rule of Law Program, in partnership with the European University of Tirana, organized on the 23rd and 24th of June, the workshop for youth interested in the strengthen of the Roma community through the development of their knowledge of minority rights and competencies, leadership and integration at local level with the theme: “Participation and engagement of Roma community in local government”.

The two-day seminar was attended by 25 young representatives of the Roma community, academic staff, representatives of local authorities and civil society organizations. The Coordinator of the Project, Ms Kebjana Haka introduced the project aims and UET Centre to the participants.

The two day seminar/workshop was conducted by international expert/speaker, experts from the field of human rights, UET lecturers, representatives of local government institutions and

international organizations.

Gender equality is a human right and one of our biggest aims towards a project implementation. Women and men's are entitled to live with dignity and with freedom from want and from fear. Gender equality is also a precondition for advancing development and reducing poverty and improves prospects for the next generation. During the implementation of this project in a strong cooperation with IRCA the Institute of Romani Culture in Albania we were engaged to promote this. In this framework we implemented three Roma Focal Point at the Local Governance. The first one Focal Point, established at the Municipality of Tirana, Roma Community were represented by two young women's and there they had the opportunity to follow their internship programme. The two others Focal Points at the Municipality of Durres and Fier, the Roma Community were represented by two boys per each municipality.

It is important to mention that during the workshops organized on 23-24th of June, 2016 with the topic related to the Participation and engagement of Roma community in local government, we observed a perfect representation of the gender balance.

The impact of the project is to increase the capacity of Roma to participate in local development and planning of local level institutions to address social inclusion. More concretely, the results of the project during June-October 2016, priority was given to the internships programme. The key target group included 6 Roma youth living in the region of Tirana, Durres, and Fieri, who then completed their 2-month internships at the respective municipalities at the local level. The Roma Focal Points in Tirana Municipality are: Aurora Koçi and Behije Kodra; Roma Focal Points in Durres: Elson Korra and Rivald Korra; Roma Focal Points in Fieri Municipality: Renart Koçi and Eduart Koçi. This project is in line with the UET Centre priorities in the field of social inclusion of Roma communities. In the framework of its Social Inclusion and Human Rights Programme, UET Centre organized on the 24th October 2016 the final activity of the project Working together and Joint Forces for Roma youth social inclusion through tailored policies and good practices on minority rights" supported by "Konrad Adenauer Stiftung, Rule of Law Program South East Europe". The final result of the project is a Policy Paper implemented by UET Centre on the engagement of Roma communities at local government, which was distributed to all relevant stakeholders and is available online at the Publication section of UET Centre website.
