MY OPPORTUNITIES HAVE BEEN ENDLESS. I LEARNT ABOUT THE CARICOM SINGLE MARKET ECONOMY (CSME) AND LEGISLATION OF BOTH HAIT AND SURINAME. I AM NOW MORE INFORMED WITH LEGISLATION THAT TIES INTO TRADE, COMMERCE AND TREATIES.

EVEN THOUGH I WAS APPROACHED BY NEIGHBORING REPRESENTATIVES FOR THIS COLLABORATION, UNFORTUNATELY THEY WERE PREDOMINANTLY ABSENT DURING THE PROJECT. THE SURINAMESE REPRESENTATIVE WAS HELPFUL FOR THE INITIAL STAGES AND DID ASSIST WITH GATHERING SURINAMESE LEGISLATION. THE HAITIAN REPRESENTATIVE WAS UNAVAILABLE. HOWEVER, THE PROJECT WAS ABLE TO CONTINUE BY THE DEDICATION OF MY TEAM AND EXTERNAL GOVERNMENTAL OFFICALS THAT SAW THE POTENTIAL OF THIS PROJECT AND OFFERED HELP WHEN REQUESTED.

#### What specific actions have you undertaken to ensure sustainability of your project?

I AM VERY COMMITED AND PASSIONATE ABOUT THE COMPLETION OF THIS PROJECT AND SO TO, IS THE MINISTEY OF ENERGY AND ENERGY INDUSTRIES STAFF. WE ARE WORKING FEVERISHLY AND COLLABORATING EXTERNALLY WITH OTHER GOVERNMENTAL AGENCIES FOR INFORMATION AND FEEDBACK FOR A PROJECT OF THIS MAGNITUDE.
