Brief description of the project:

This project is to promote the development of responsible artisanal and small scale mining in Yoke Village, Muyuka Sub Division, Fako Division in the South West Region. Therefore improving the well being of artisanal and small scale miners (Men, Women and Youths) in a cost effective on environmental friendly extraction methods in a sustainable manner thus contributing to rural development and poverty reduction.







What were the expected outcomes and what outcomes did you achieve?

- Harm reduction, community stability, goal setting and behavioral change which are easier for groups than individuals.
- To stop the tedious and dangerous methods of extraction.
- To prevent ASM from engaging in clandestine mining.
- To improve in their working conditions.
- The ASM are willing to use protective wears for the prevention of risk.
- The ASM accepted to be legalized with regulatory framework.
- The positive response for the project to be implemented and possibly assistance or grants will be appreciated by the ASM.
- The willingness to address cultural beliefs on women autonomy.

What were the expected outputs and what outputs did you achieve? Please be specific. The workshop was held in Yoke at the banks of the Mungo river on April 6th 2017. The attendance was twenty (27). The gender balance was eight (8) women which one of them was a quarry owner, five (5) are food sellers, one (1) sells water and another one (1) doing petty trading:- selling cigarettes, alcohol in sachets, drinks etc., of the (ten) 10 men, we had four (4) as canoe drivers and six (6) divers. The nine(9) Youths were loaders from step one to step five where vehicles come to load the sand for transportation to sell to the various customers in town.

The key partnership that was established was with ASM, quarry owners, indigenous communities, women, the Muyuka, Buea Councils, and ACP-EU project on development minerals programme implemented in partnership with UNDP.

I succeeded to encourage the exchange of experience, information and knowledge sharing among ASM. I also build a collective cognition to know who they are, where they came from, where they are located and the critical factors that affected their activities and livelihood which needs to be addressed and changed.

Strengthening the capacities of ASM specifying their roles and responsibilities on safety measures, health care, hygiene and environmental friendly mining. Also, the promotion and support for value chains to achieve good results.

Please explain any problems encountered during implementation of your project, highlighting any deviations from the project plans (Describe the solutions sought for the problems and corrective actions undertaken for the deviations)

With my perfect knowledge on the task they taught in the seminar, I acquired an array of skills, cognitive, perceptual and procedural etc. The administrative experience and technical knowhow while serving as a Divisional Delegate, Regional Controller of mining activities and a sworn Inspector of mines in the ministry of mines, industry and technological development in Cameroon. I have been controlling, advising ASM and reporting their activities to the government. Also, in my community role as a mayor interacting with ASM and the indigenous population on sustainable mining practices.

The only problem I encountered was means to fuel my car to the various villages to meet the ASM and entertainment after the meeting which amounted to: (Fuel – Limbe to Muyuka to Limbe 10,000 frs X 3 = 30,000 FCFA), (entertainment 30,000 X 3 = 90,000 FCFA) a total of One Hundred and Twenty Thousand (120,000) francs CFA.

What specific actions have you undertaken to ensure sustainability of your project?
