EXPECTED OUTCOMES AFTER 3 YEARS :

- 1 000 Km of rural road rehabilitate
- Job Creation: At least 1 000 000 Jobs will be created in 3 years.
- Direct Fight against Hungry: The job immediately created will help in a short-term to fight against hunger.
- Poverty Reduction: Increase the Income of the Population of the Rural areas.
- Sustainable and Better Infrastructures: The Cobble Stone Project could be used for 25 years at least and it will allow a better circulation of goods and people.
- Non-Direct expected Outcomes: Better Access to health care, Better access to education for the Children because of the enhancement of the local economy.

OUTCOMES ACHIEVED :

- 154 KM of rural road with 80% chance to be realized.
- Job creation: Not available (Work just begin now).
