GROUPING OF ARTISANAL AND SMALL SCALE MINERS IN ABIA STATE INTO CLUSTERS AND PROVIDING TECHNICAL AND FUNDING SUPPORT FOR THEM

What were the expected outcomes and what outcomes did you achieve?

The Expected outcomes were: OPTIMIZATION OF OUTPUT, HEALTHIER SAFER OPERATIONS, GREATER CONCERN FOR THE ENVIRONMENT, INCREASED PRODUCTIVITY, MECHANISED OPERATIONS

Outcomes achieved: WE HAVE BEEN ABLE TO GROUP ARTISANAL MINERS IN ABIA STATE INTO CLUSTERS, WE HAVE GOTTEN THEM TO ADOPT MORE ENVIRONMENTALLY FRIENDLY METHODS OF OPERATION, WE HAVE HELD PERIODIC SEMINARS FOR









THEM THUS INCREASING THEIR CAPACITY FOR THE WORK THAT THEY DO, WE HAVE GOTTEN THEM TO ADOPT HEALTH AND SAFETY BASIC STANDARDS IN THEIR OPERATIONS.

Expected Outputs: MORE JOB OPPORTUNITIES, IMPROVED DIGNITY OF LABOUR, MORE OUTPUT FOR LESS WORK

- On Tuesday, May 3, 2016, we held a workshop with operators in the Solid Minerals Sector of Abia State to share with them what we learnt at the Ghana Workshop. The workshop was held at the Aguiyi Ironsi Conference Centre, Umuahia, Abia State. There were 86 Solid Miners in attendance and 12 of them were women.
- 2. On Thursday, June 16, 2016, we got the Abia State Government to inaugurate the Abia State Mineral Resources and Environmental Management Committee which is the vehicle through which we intend to carry out the implementation of the Return to Work Plan (RWP)
- 3. On Thursday, August 25, 2016, we held an outreach programme as an Artisanal Mining Cluster at Umunneochi Local Government Area in Abia State where we gathered the Artisanal Miners and explained to them the benefits of safer operations and coming together as a cluster so that we can reach them in a more organised way. There was only one woman in a group of 14 that were present at the site when we came.
- 4. Our activities have greatly improved dignity of artisanal mining in Abia State.

Please describe the key partnerships and collaborations that you established in your country as well as any joint collaboration with other countries

We have held a meeting with the Minister of Solid Minerals in Nigeria, Dr. Kayode Fayemi and in the course of the meeting, he asked that Abia State Mineral Committee be included in an assistance program being funded by the World Bank. We have also established a working relationship with the Ford Foundation for capacity building for miners in Abia State through periodic mobile clinics.

What indicators of success have you achieved since the start of implementation? (Describe the indicators of success in relation to the expected outputs and outcomes)

- 1. We have gotten the Artisanal Miners in Abia State to come together in clusters which has enabled us reach them easier and disseminate information and training.
- 2. We have inaugurated a State Committee to serve as vehicle for the implementation of our RWP
- 3. We have disseminated information on current best-practices in safe mining to artisanal miners in Abia State
- 4. We have established linkages with the Federal Ministry in charge of Solid Minerals and we are now fully integrated in their activities.









What strategic opportunities have you acted upon that have contributed to the continued success of your project? (include linkages to sub-regional and regional agendas)

We have consolidated on our relationship with the Federal Ministry of Solid Minerals and that has opened new vistas of support for Solid Mineral development in Abia State

We have strengthened our relationship with UNDP which has guided us in our activities leading to increased output and increased capacity.

What opportunities opened up for you personally as a result of your RWP?

I have been consulted by the Federal Ministry of Solid Minerals with financial benefits on some of their activities where they have invited me to share our RWP which has been adjudged a workable solution to some of the challenges of relating with artisanal miners in Nigeria.

Please explain any problems encountered during implementation of your project, highlighting any deviations from the project plans (Describe the solutions sought for the problems and corrective actions undertaken for the deviations)

The problem we encountered initially was resistance from the miners who felt we were coming to collect additional revenue from them. As soon as we were able to win their trust and get them to understand that we were bringing them solutions for improved productivity, they embraced us. We did not have to deviate from the plan, we only introduced additional advocacy visits to reassure the miners of our intentions.

What specific actions have you undertaken to ensure sustainability of your project?

The setting up of the Committee is an institutional framework. If we are not there tomorrow, new members are simply appointed and the committee continues its operations. We are also on the verge of registering a State Mining Company which will aggregate the artisanal clusters we have set up and work with them going forward to find markets for their products and aid them in their operations.
