# ASSESSMENT OF NEGLECTED DEVELOPMENT MINERALS AND CAPACITY BUILDING (GEARED TOWARDS) SUSTAINABLE EXPLOITATION IN SIERRA LEONE

#### **GENERAL INFORMATION**

## **Brief Description of the project:**

Neglected Development Minerals provide crucial inputs for domestic economic development in Sierra Leone, such as infrastructure, manufacturing, construction and agriculture, and on the increase in recent time. They have high potential to impact on livelihoods; their production activities provide the highest opportunities for employment, particularly for the local community, also can serve as alternatives for socio-economic development in the means of fall in international market prices of metals and other high values minerals but yet neglected. Neglected Development Minerals mining activities (Granite Aggregates, Sand Extraction, Clay Exploitation etc) are found all over Sierra Leone but not properly regulated and their impacts not reflected in the national economy. Hence there is therefore the need to assess and determine Neglected Development Minerals exploitation in Sierra Leone.

Thereafter communities have to be sensitized on the formation of associations to ensure better dividends from their exploitation activities. Environment Protection Agency'- Sierra Leone (EPA-SL) and the National Mineral Agency (NMA) have to embark on training and awareness creation of the mining communities to realize the benefits from the use of Personal Protective Equipments (PPEs) and environmental management in the entire stages of the exploitation.

### **Expected Outcomes:**

- Available information on the extent of Neglected Development Minerals exploitation,
- Communities Training and Sensitization programs available,
- Review of Chiefdoms Byelaws to ensure sanity in the exploitation of Neglected Development Minerals and
- Establish a data base of all Neglected Development Minerals present in Sierra Leone.

### **Expected Outputs:**

- Identify/creates geo-data by chiefdoms on the types of Neglected Development Minerals in Sierra Leone,
- Identify the use of each of the Neglected Development Minerals,
- Train communities involved in the exploitation as follows:
  - Method of mining
  - Environment, Health and Safety Management
  - Formation of Associations
  - Value Addition
  - Improvement of market structures for NDMs produce
- Community sensitization on the involvement of Stakeholders in Neglected Development Minerals Exploitation and
- Awareness creation on the reviewed community byelaws

development of policies in the acquisition of land and environmental management.

**Agencies:** Environment Protection Agency Sierra Leone, in charge with the overall mandate to effective protect Sierra Leone's environment, advise the president on sound environmental management practices and also serve as the focal point for all Multilateral Environmental Agreements (MEAs); National Minerals Agency, in charge of the mining and mining environment; National Protected Area Authority, in charge of the management of protected areas; Decentralization Commission, in charge of capacity building of local governments.

**Private Sector:** In the driving seat of sustainable business initiatives coupled with value addition for national development.

**Civil Societies and Non-Governmental Organizations:** Play the common factor rules, undertake advocacy and the whistle blowers
