- ✓ It is a response to new trends which demand a closer interaction between development actors and partners.
- In 2014, the PFD evolved from the Structured Dialogue which brought together 700 Civil Society Organizations (CSO) and Local Authorities (LA) and the EU institutions recommending the European Commission to establish a regular space for dialogue.
- ✓ It brings together CSOs and LA representatives from all over the world to discuss European development policies and global development agendas.
- Need for an improved dialogue and forging stronger partnerships, as stated in the new European Consensus on Development.





## What is the PFD?

The PFD is a multi-stakeholder space for dialogue offering CSOs and LAs as well as European Institutions, a venue to exchange experiences and discuss development issues.

Its objectives are:

- 1. Facilitating dialogue on cross-cutting issues related to the role of CSOs and LAs as development actors;
- 2. Promoting policy debate, consultation and exchange of information on EU main policies and initiatives in development;
- 3. Providing a room for regular update and peer review.





# Who is a member of the PFD?

- 62 networks and associations of CSOs and LAs
- representatives from EU Institutions,
- Member States (at global meetings).

Mandates are assigned to organisations (Networks/Associations), their representatives are selected by the members on the basis of:

- Capacity to represent the views of their constituencies, providing them with regular feedback from the PFD;
- Commitment and availability to take part in the PFD and
- Gender balance

# How does it work in practice? (I)

Regular dialogue on issues such as:

- Enabling Environment
- Implementation of the 2030 Agenda
- Role of multi-stakeholder partnerships

This is done through:

- Global and regional meetings
- Research
- Joint papers and working groups
- Participation in other events (European Development Days)





# How does it work in practice? (II)

Coordination by the European Commission (Directorate General for International Cooperation and Development - DEVCO) + active commitment/ participation by stakeholders.

Chaired by DEVCO + co-Chairs from the CSO and LA stakeholders.

- PFD Task Team (TT) is chosen by the PFD members to oversee and steer the forum:
  - helps maintain communication between PFD meetings;
  - undertakes preparatory work, agenda setting; and
  - monitors the functioning and performance of the PFD.

Phase I of PFD Research completed: Implementation of 2030 Agenda (Netherlands, Ghana, Indonesia & Peru). Currently planning the new phase.
